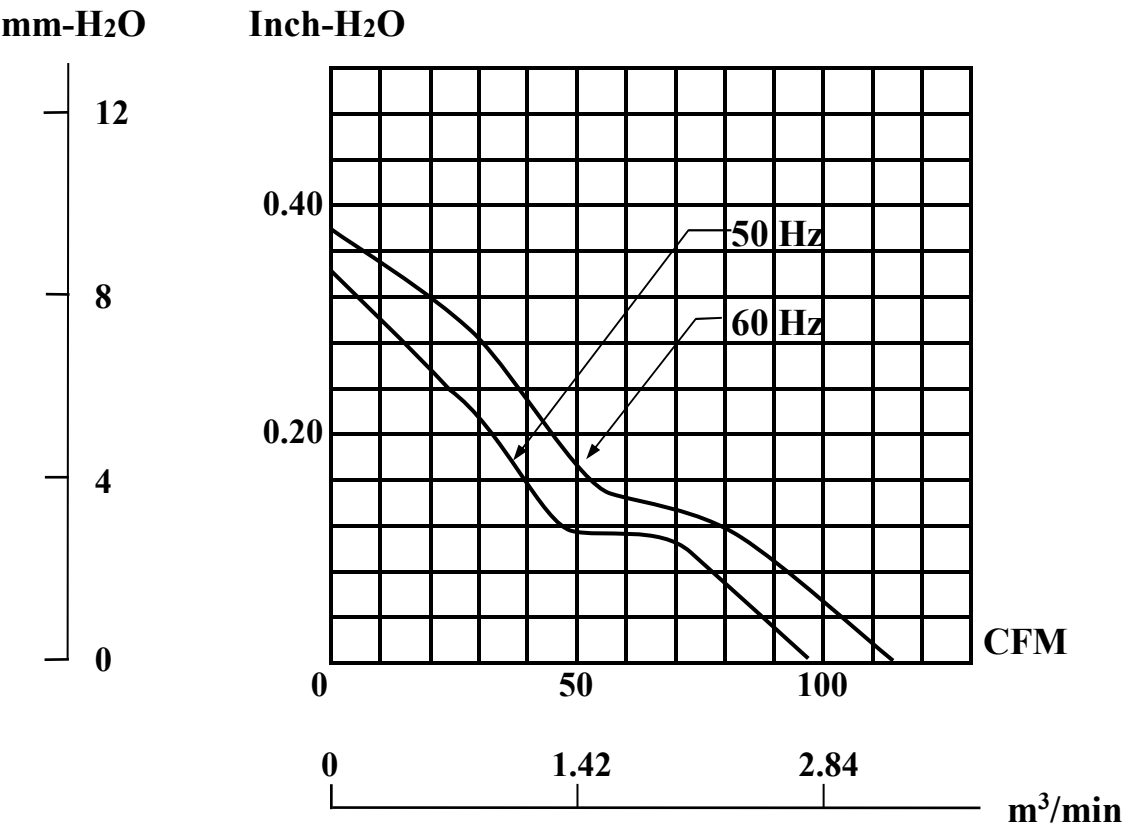

PRESSURE

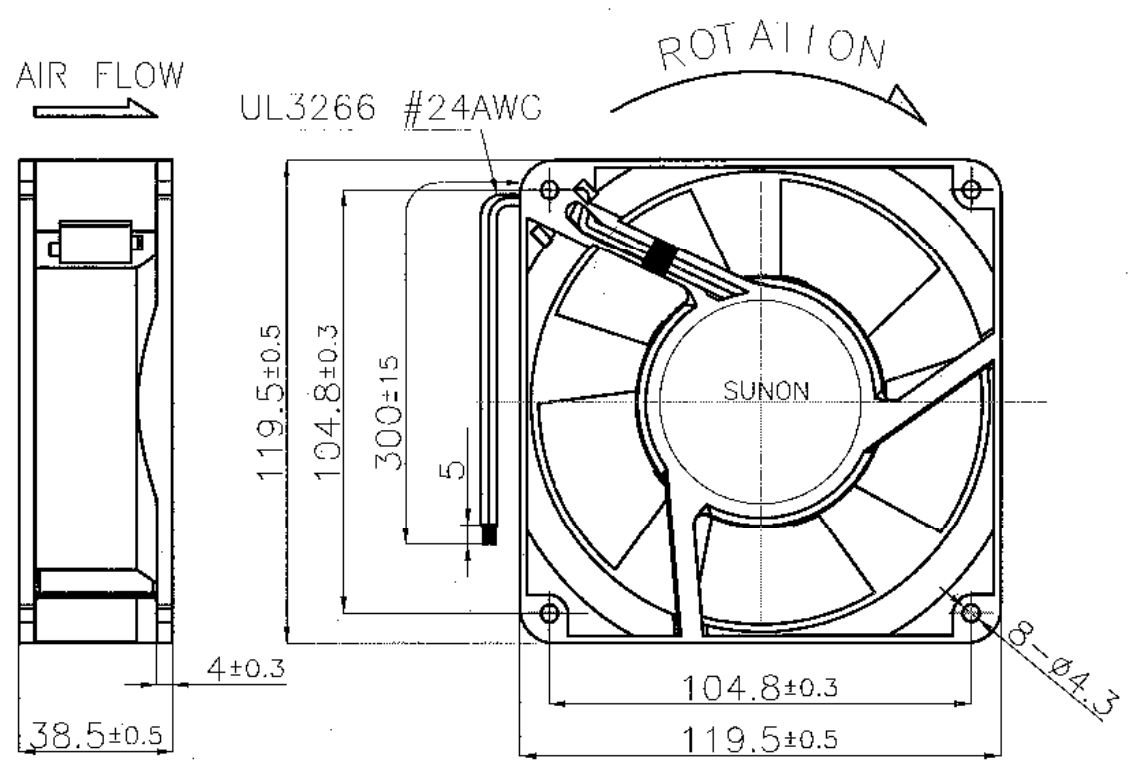
