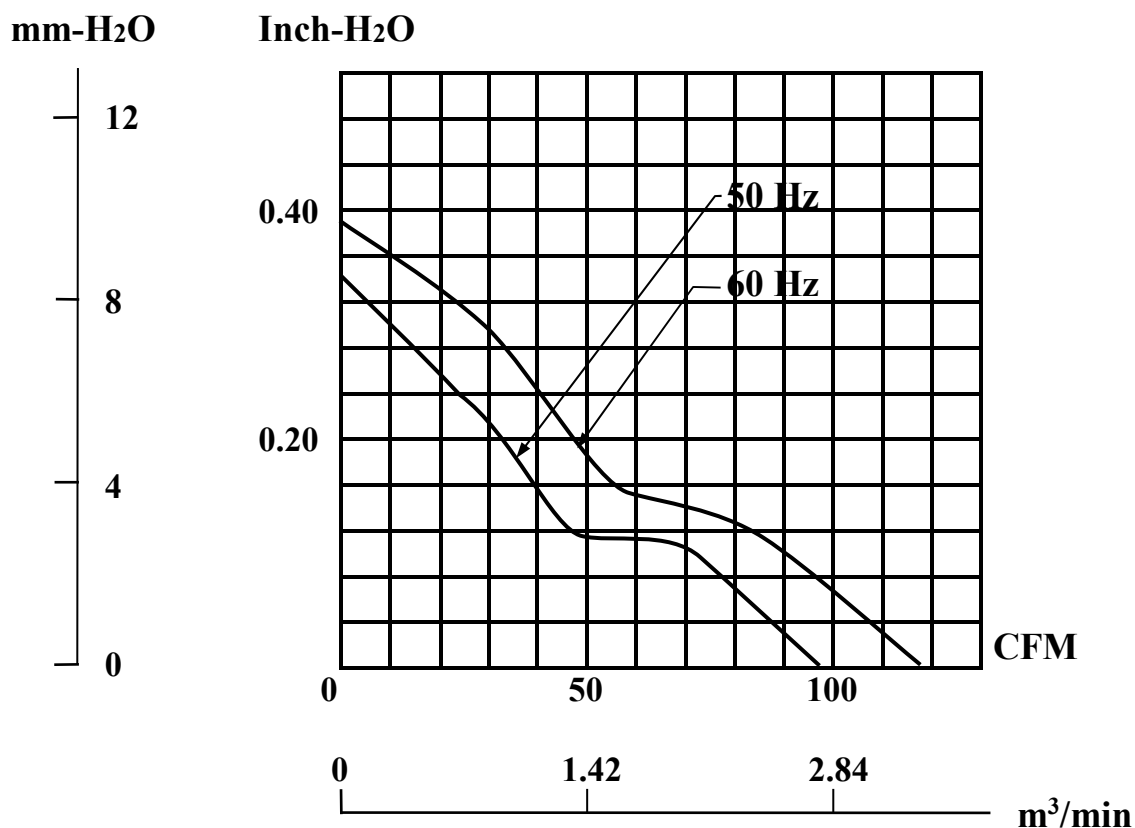

PRESSURE



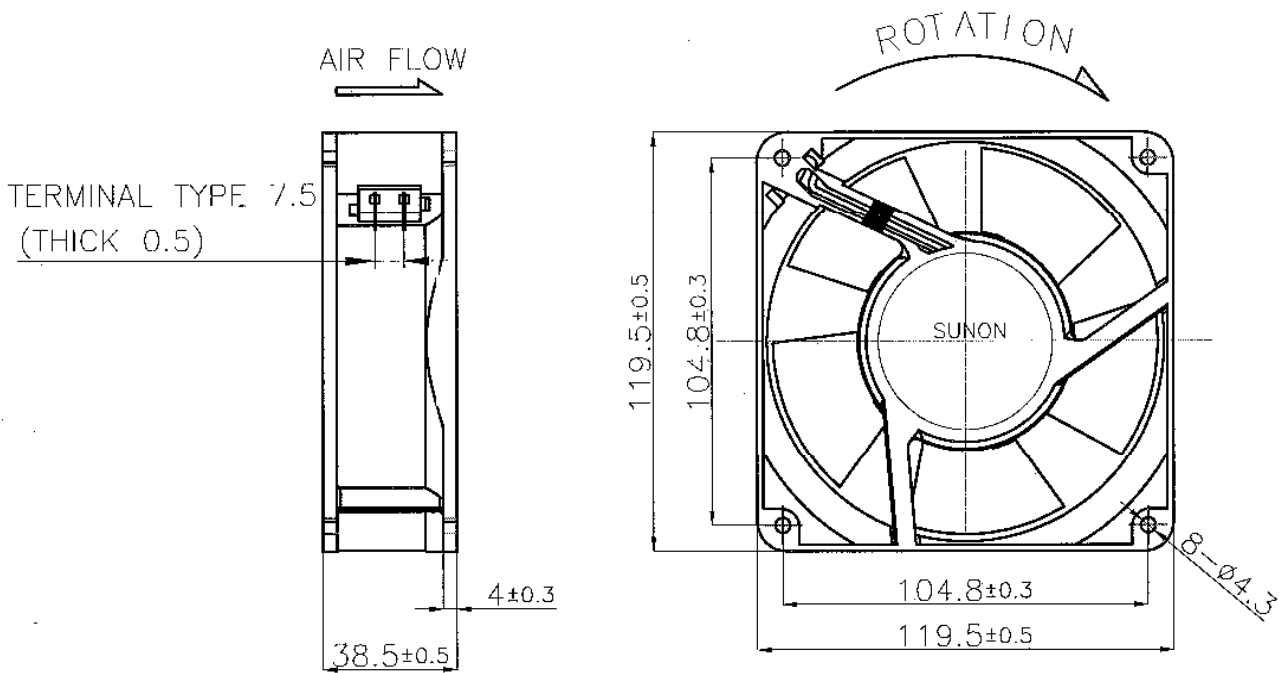
