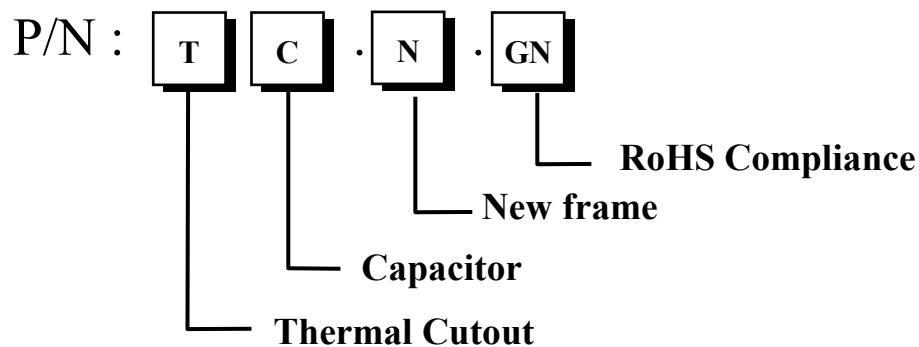
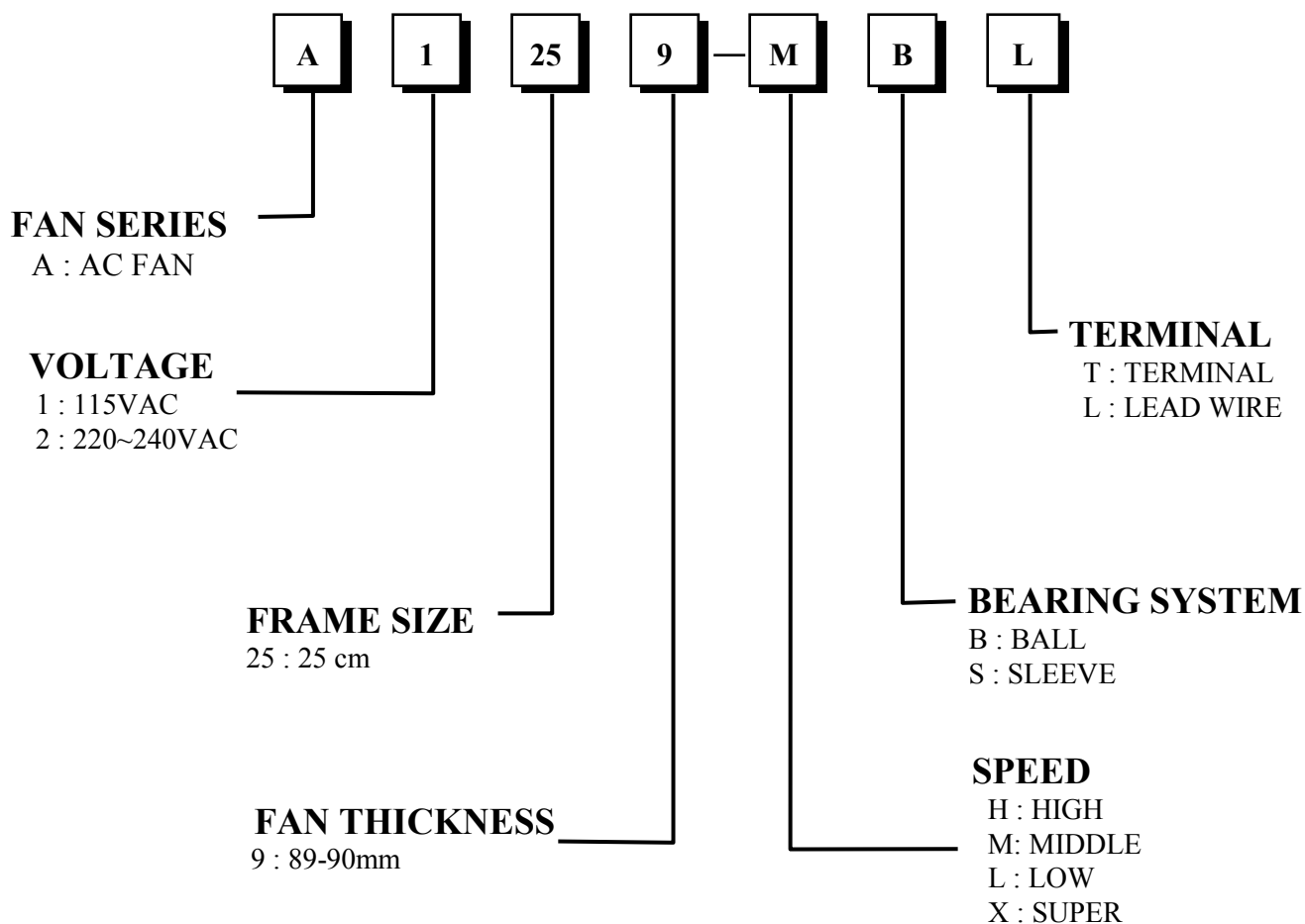

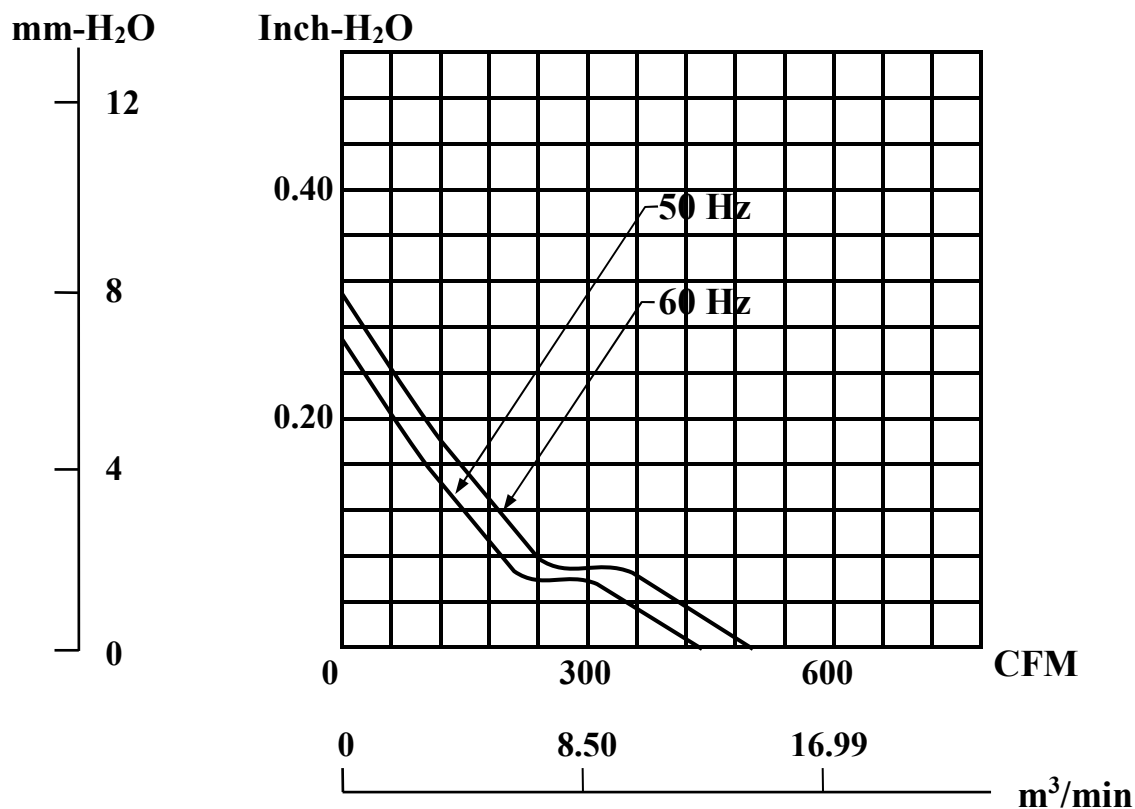

PRESSURE

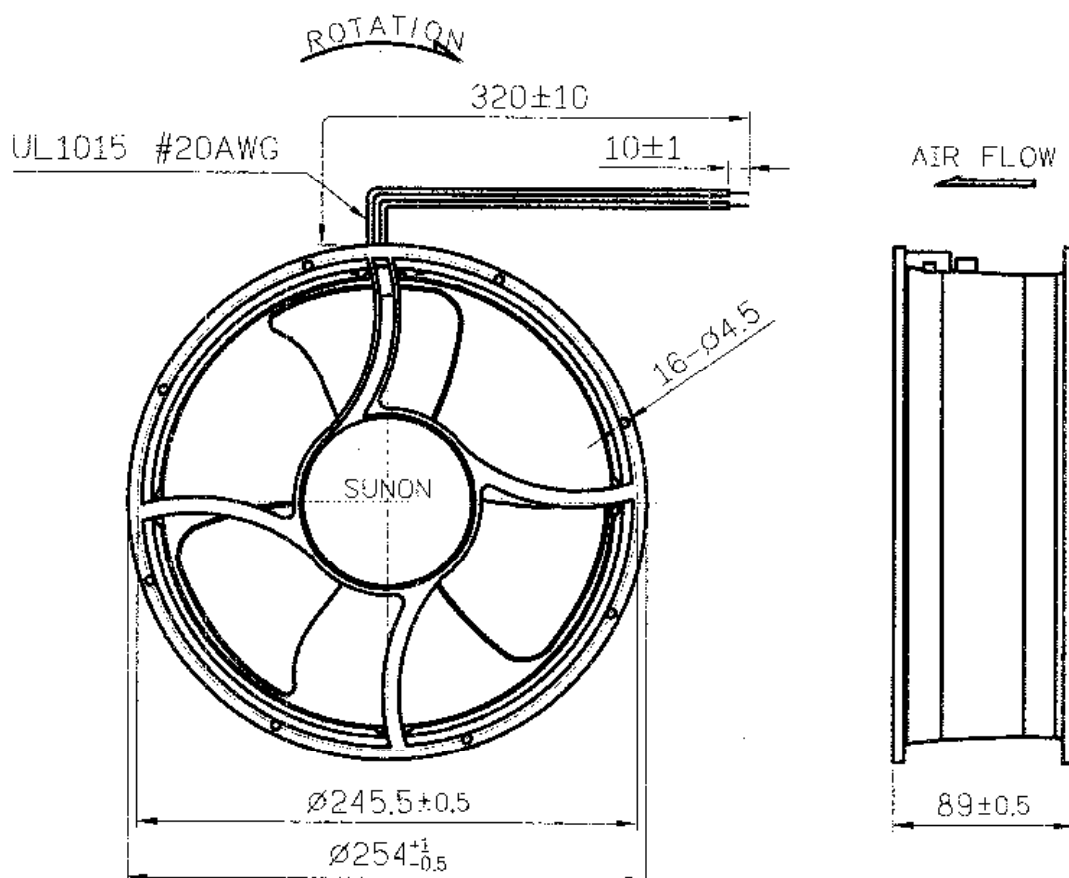

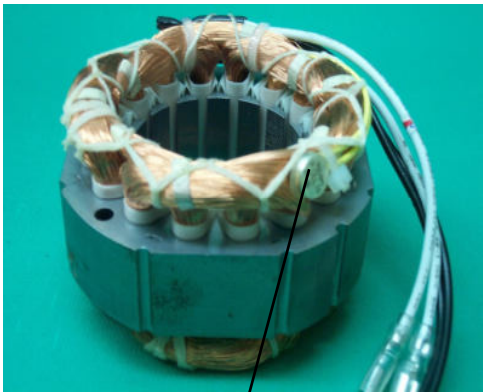
