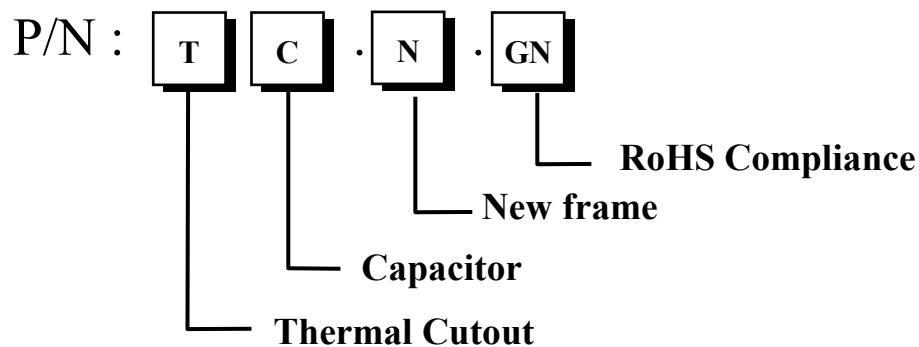
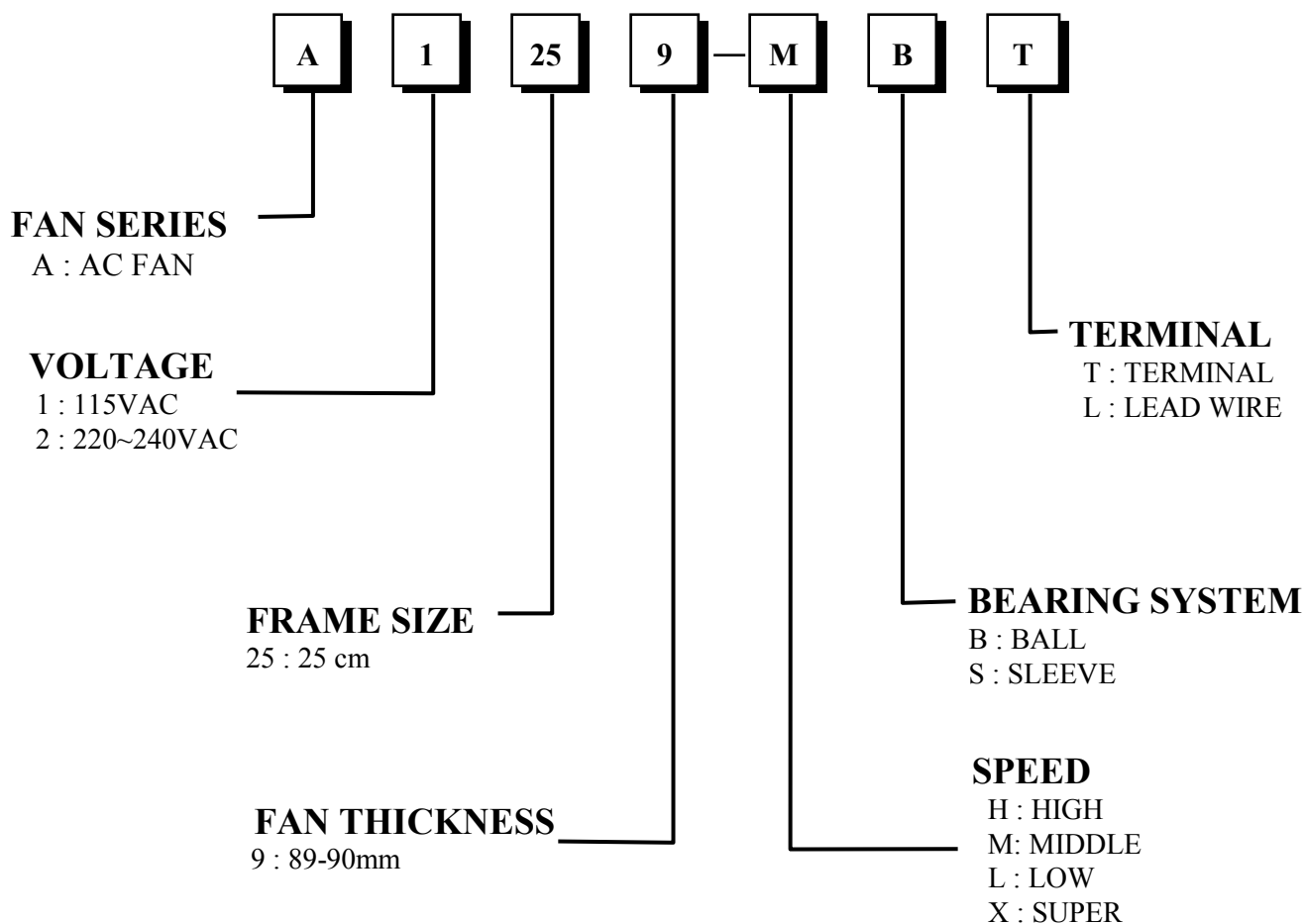

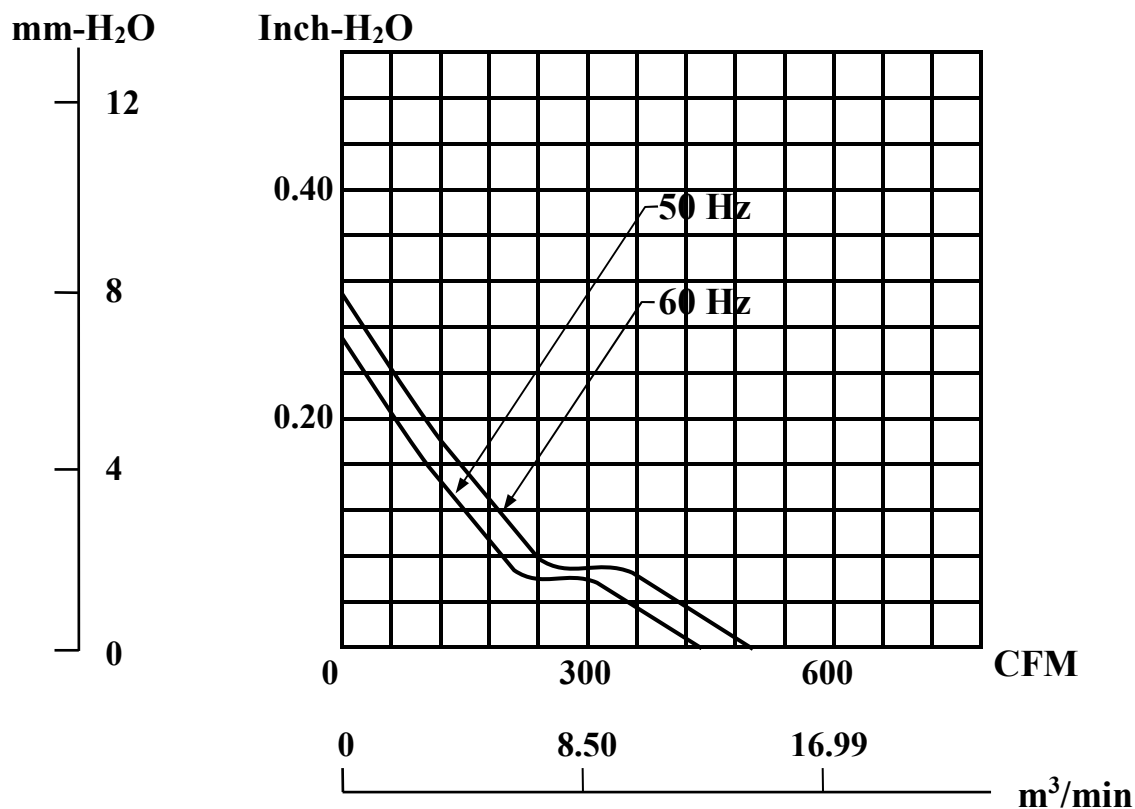

PRESSURE

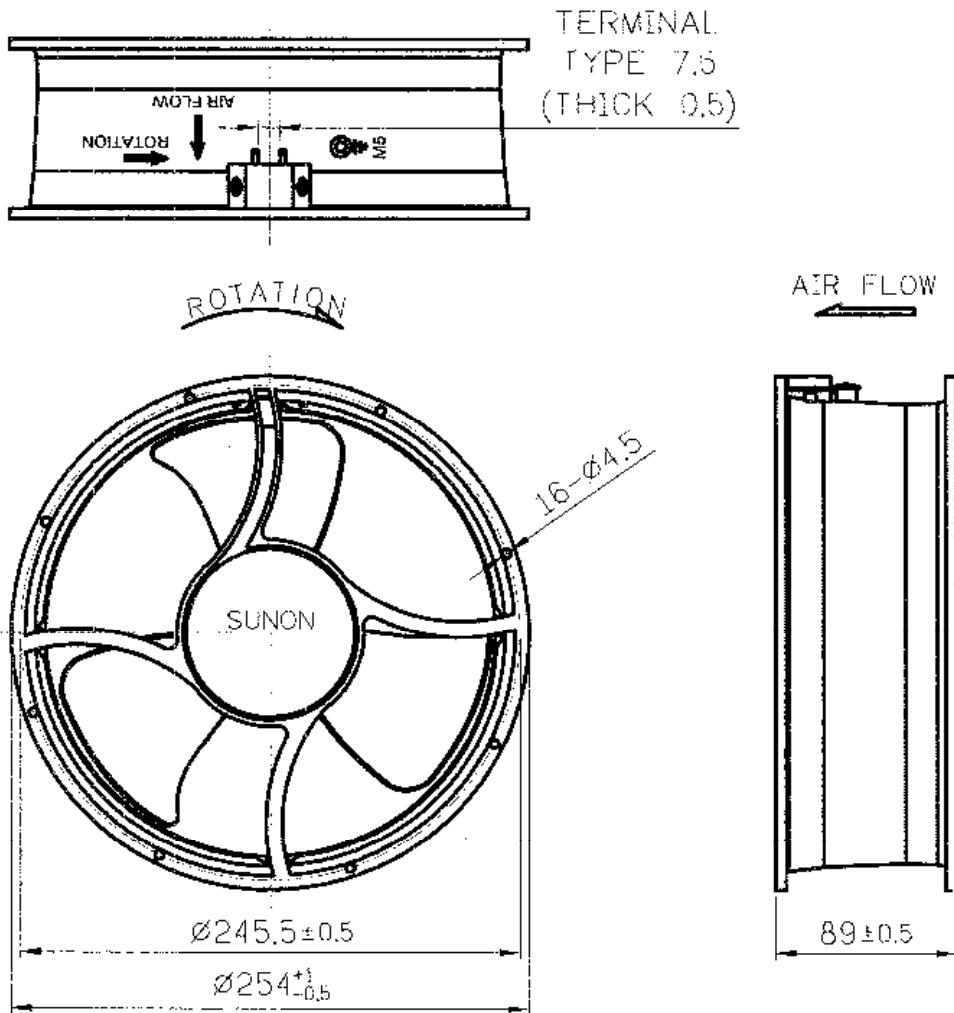

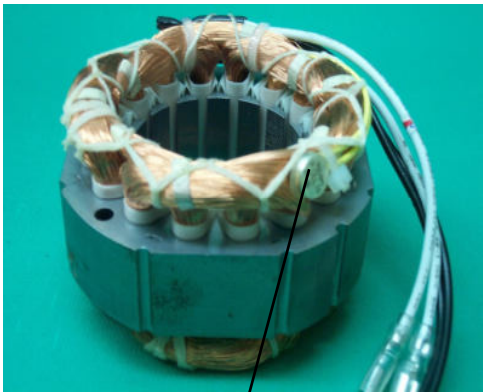
