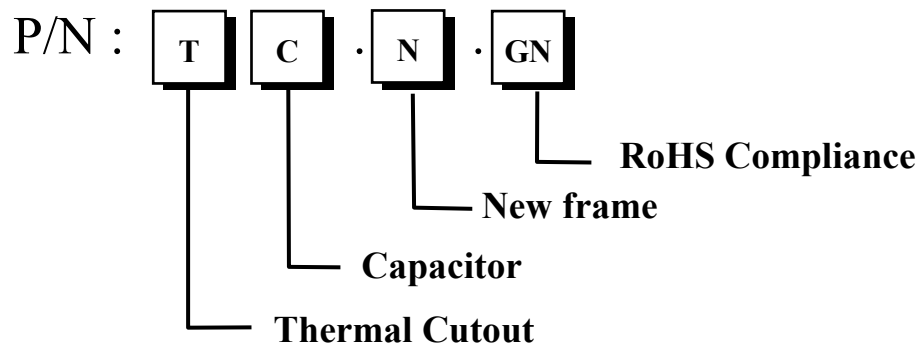
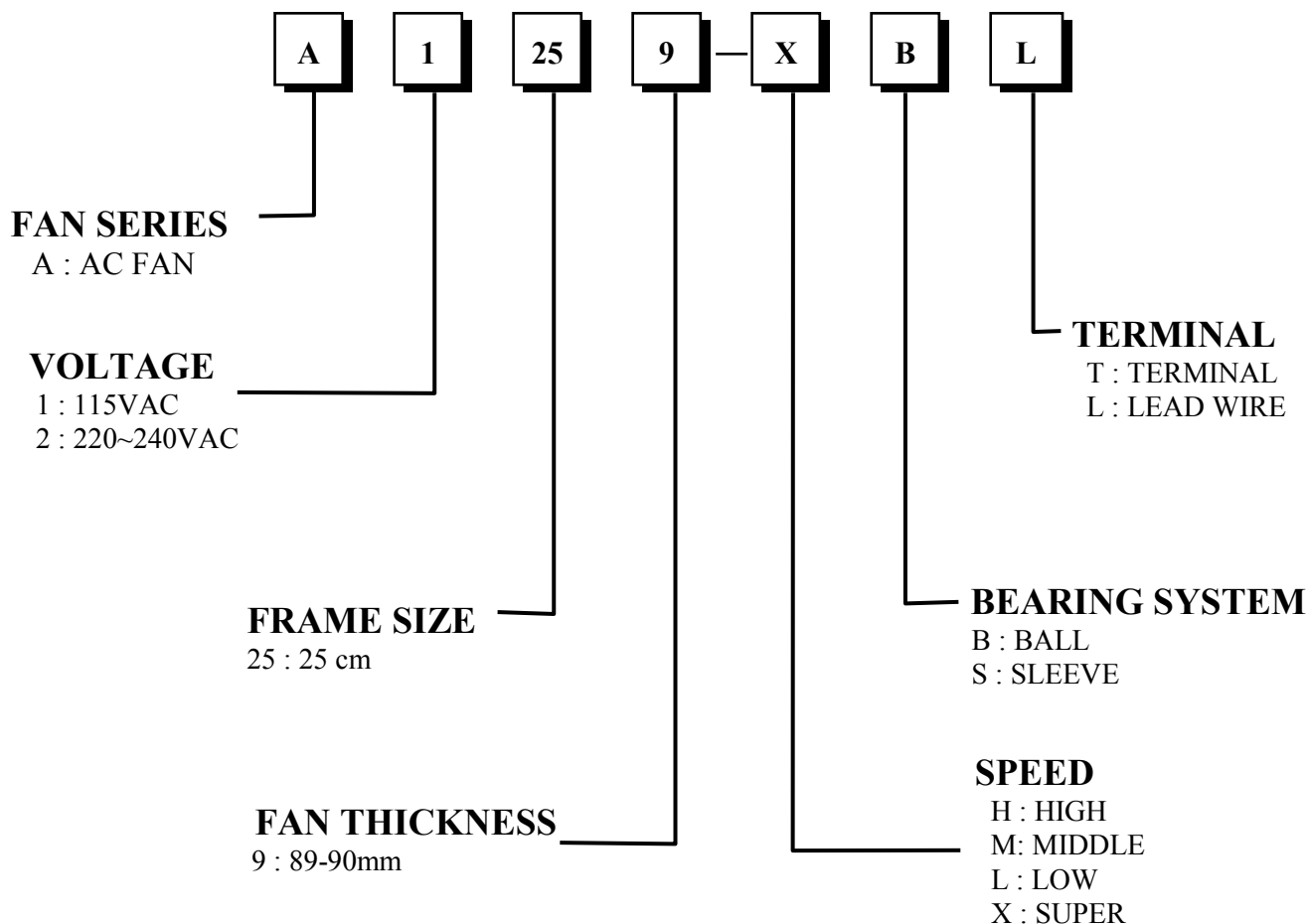

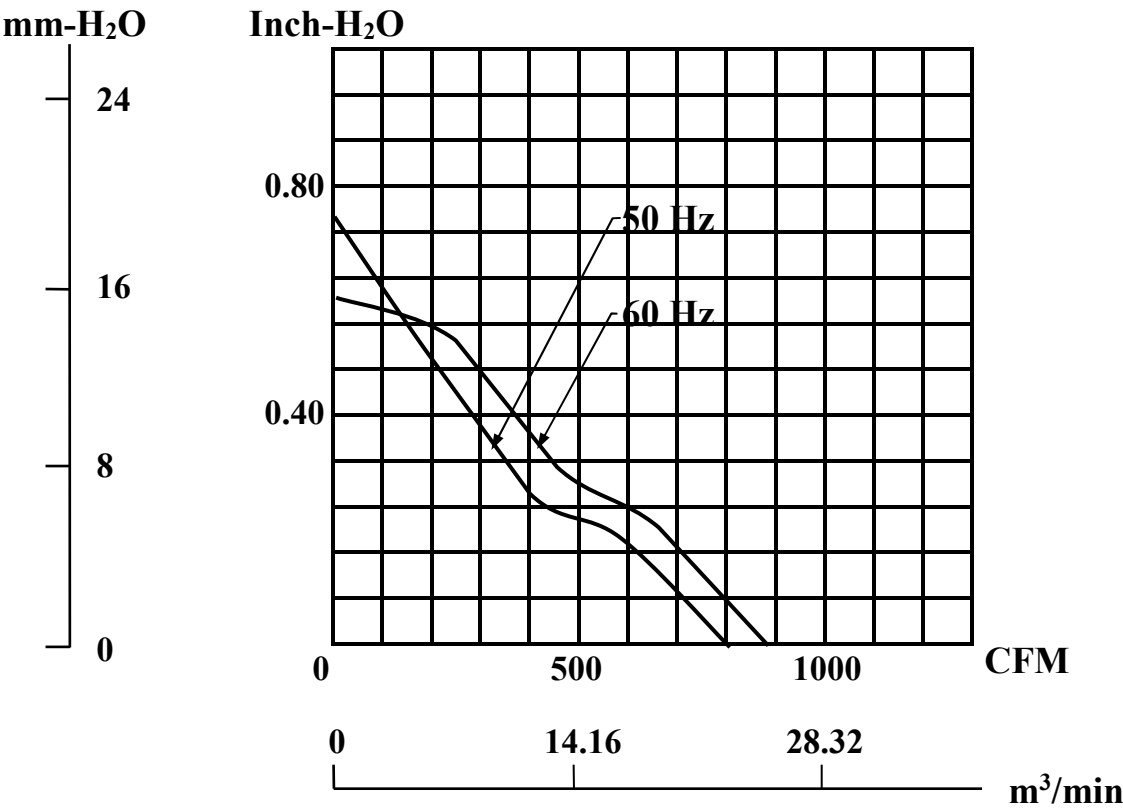

PRESSURE



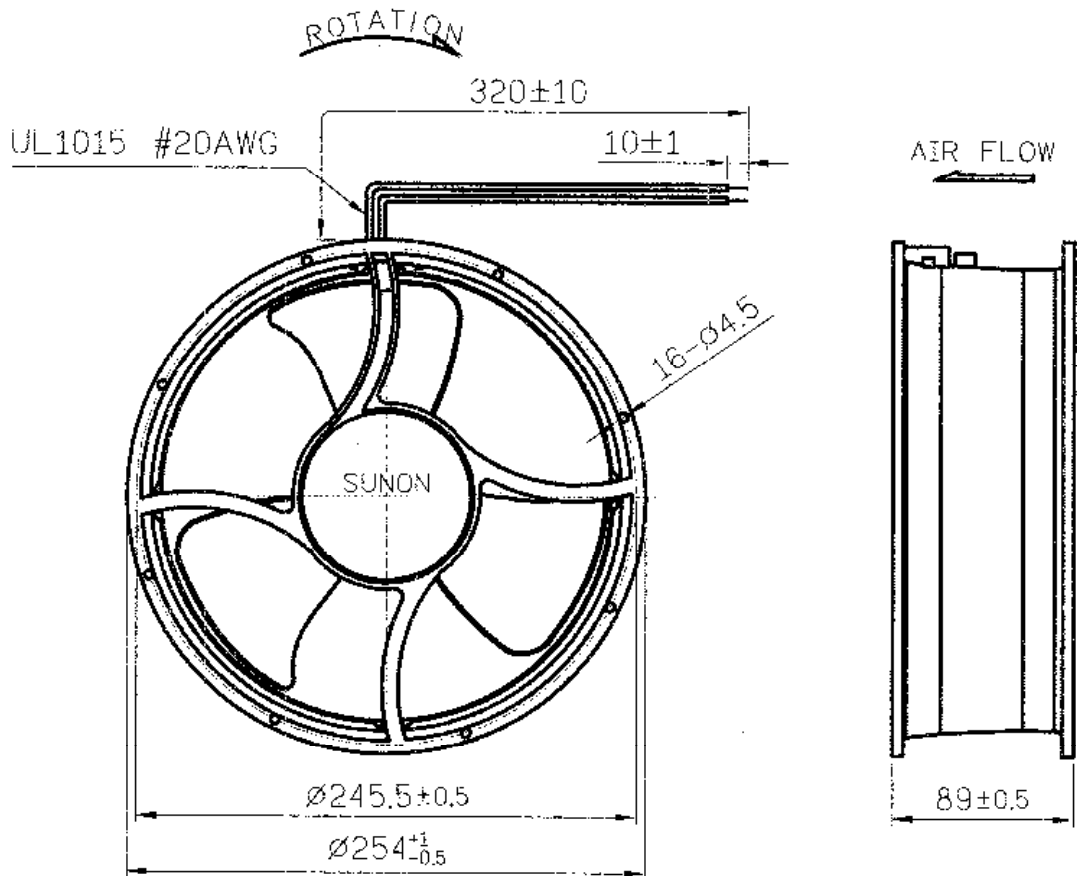

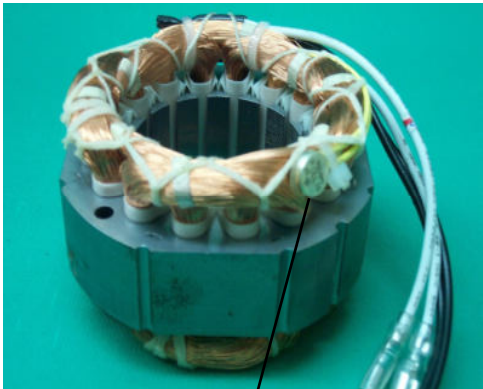
