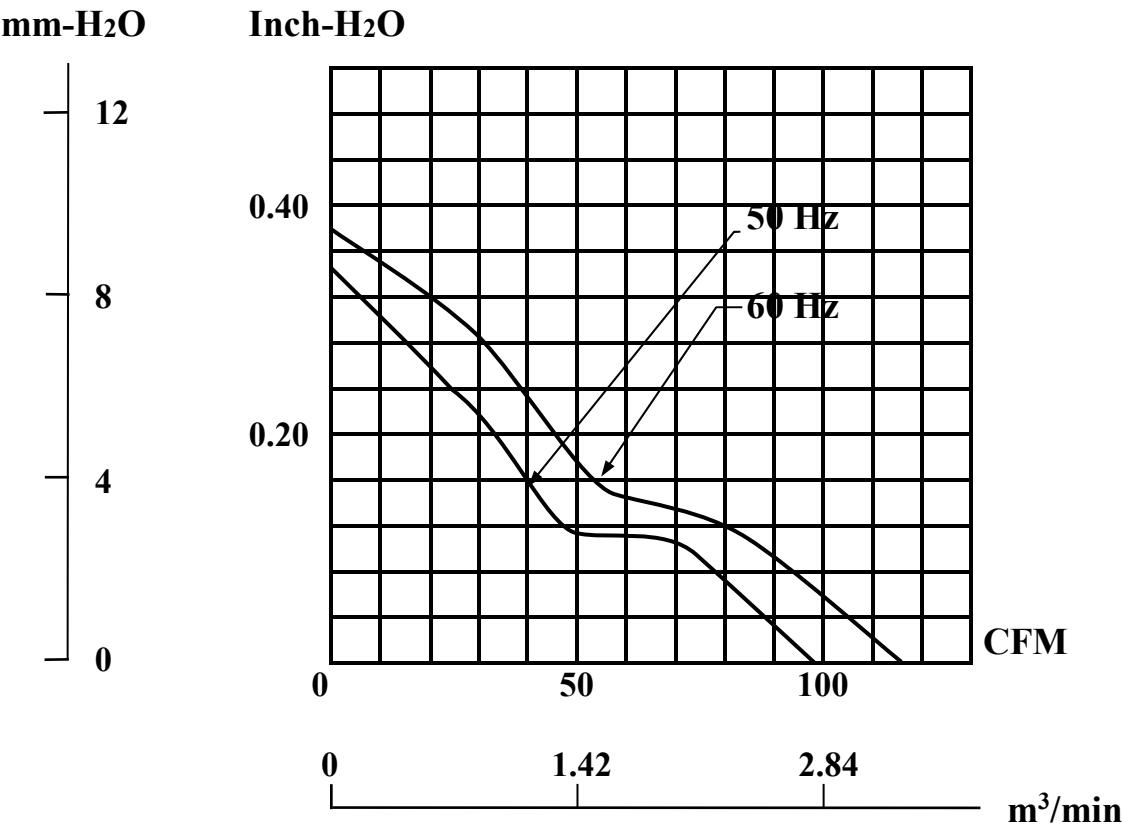

PRESSURE



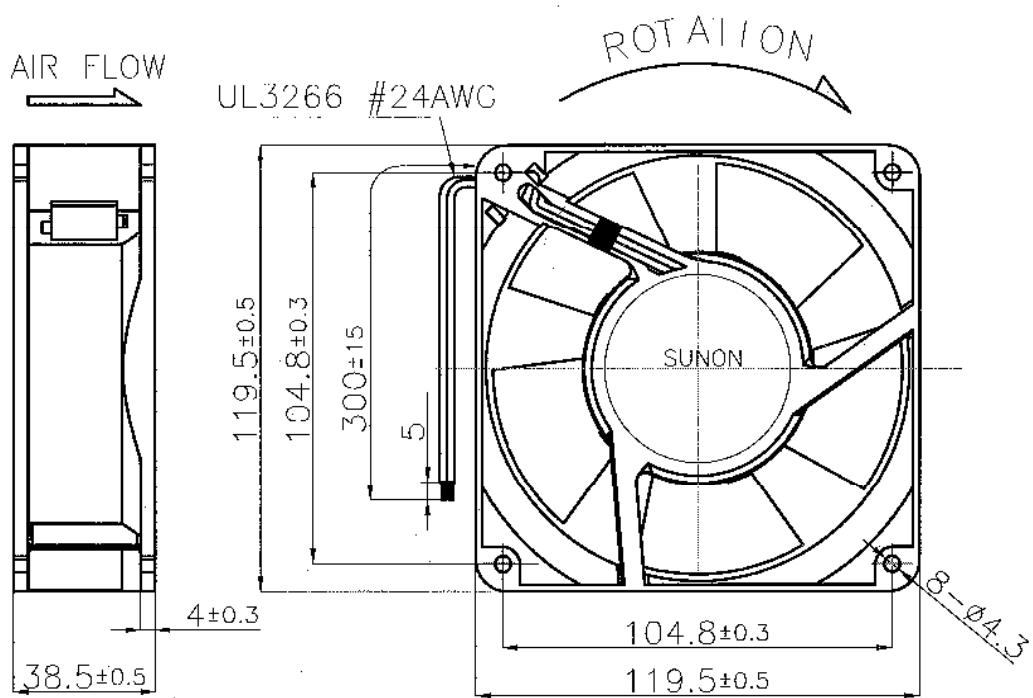
