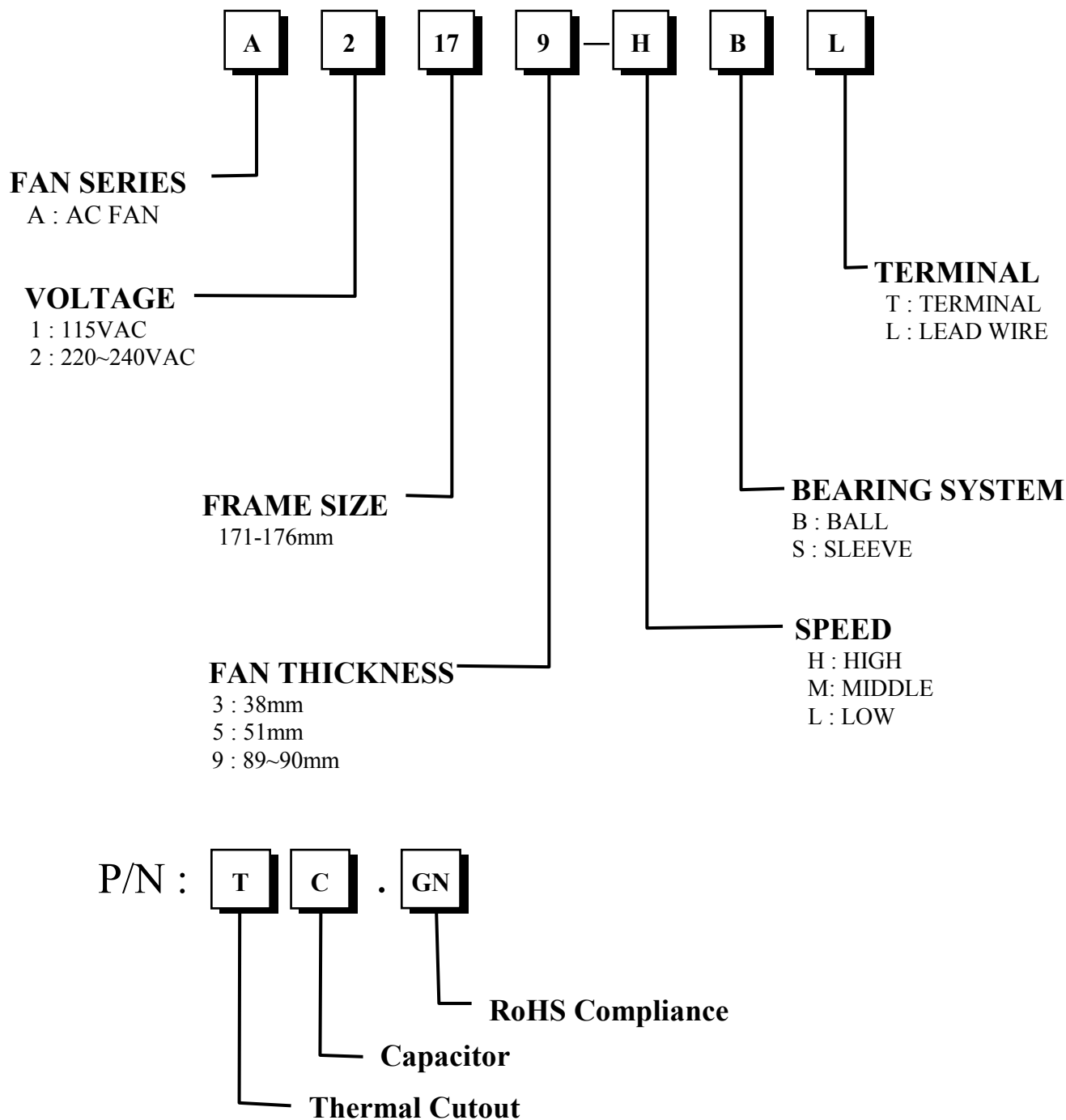

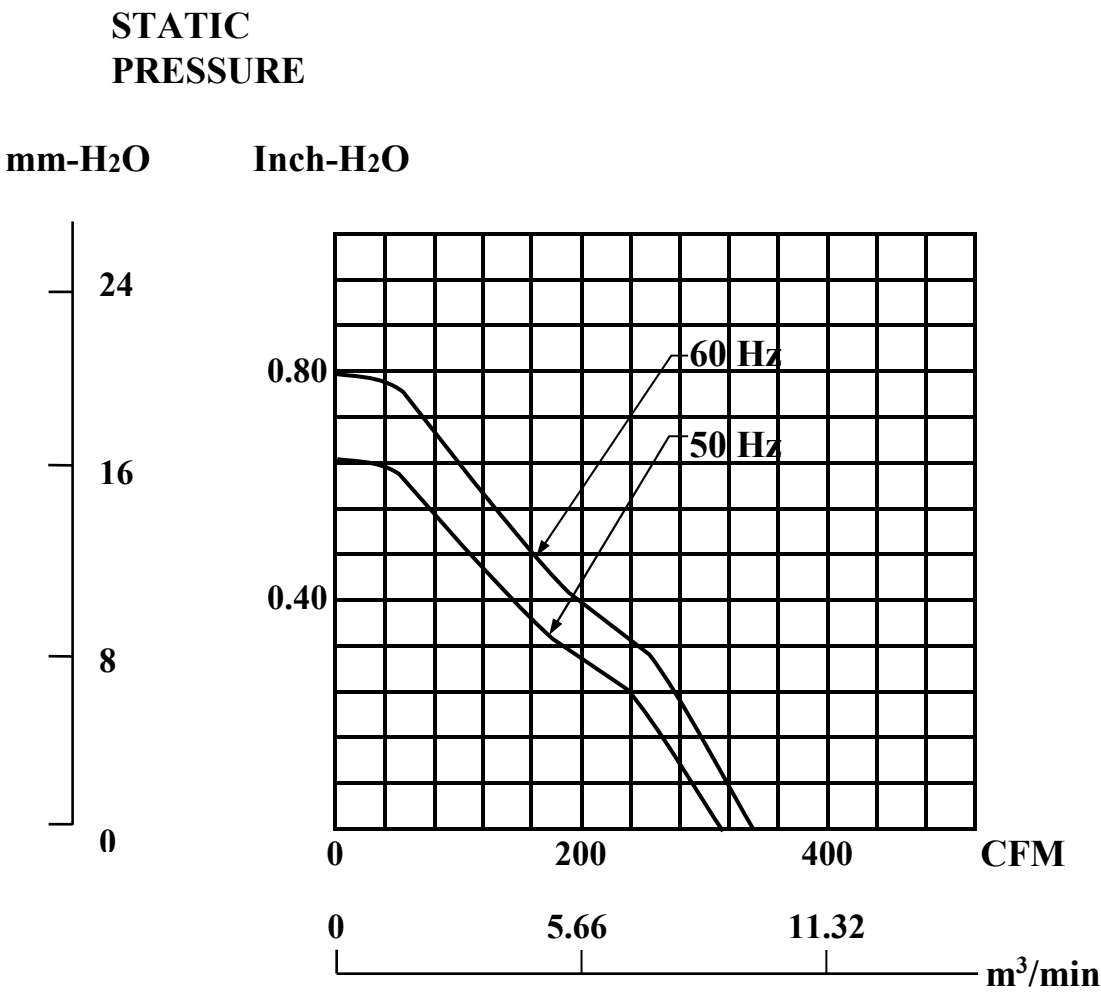

PERFORMANCE CURVES



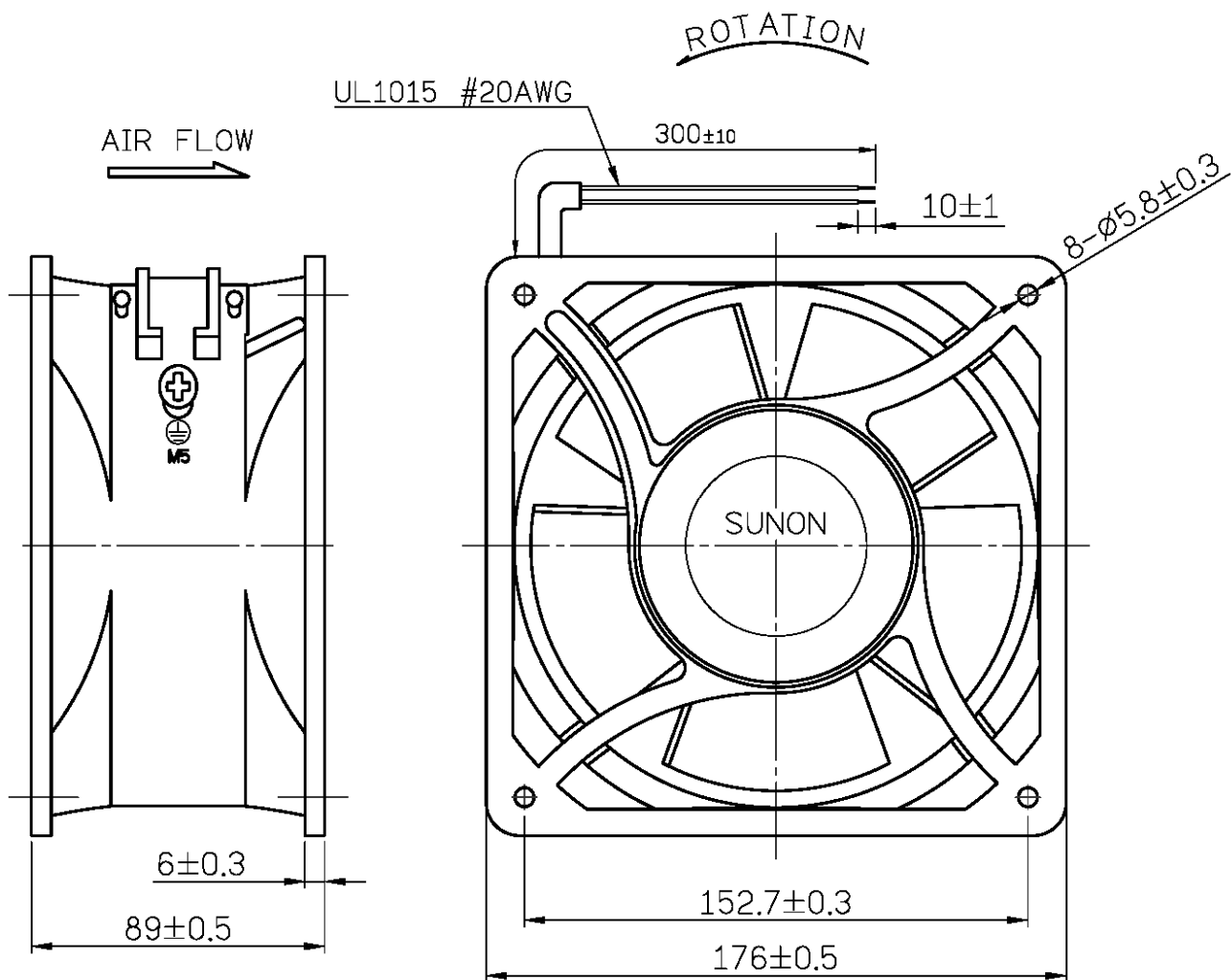

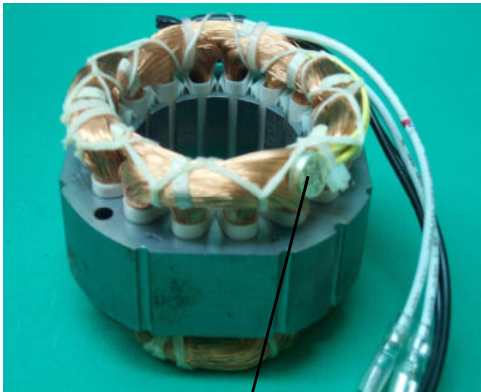
