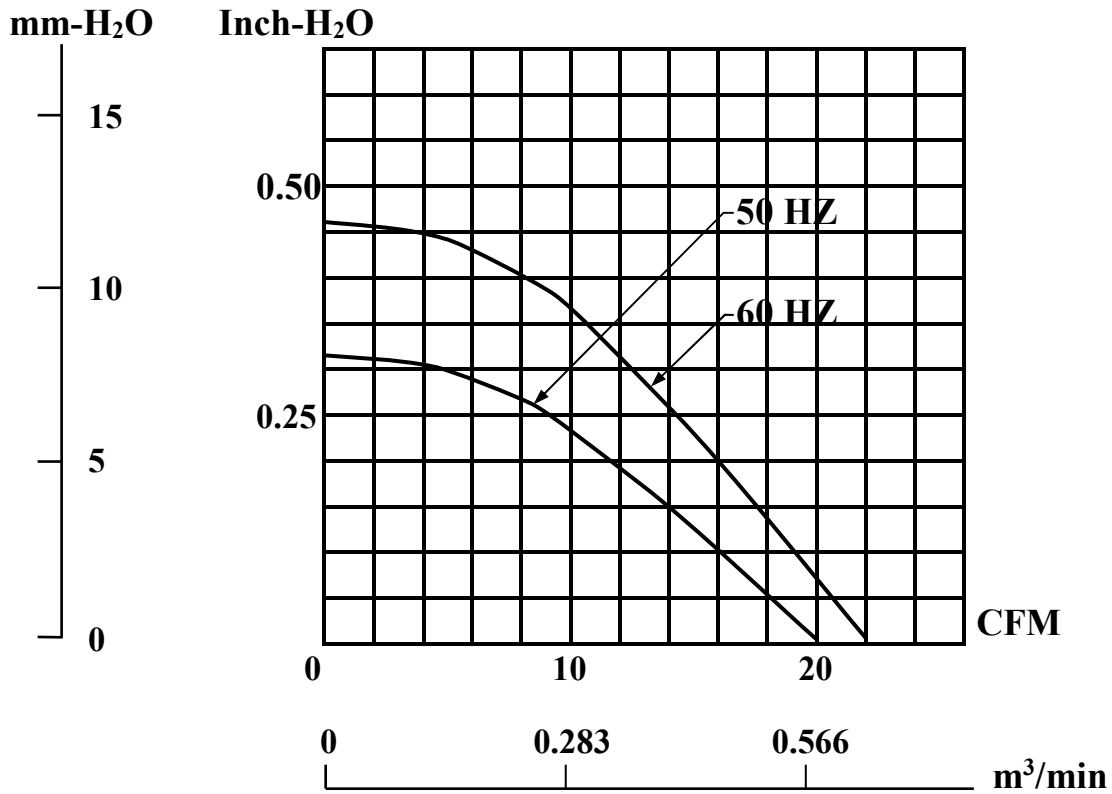

PRESSURE**



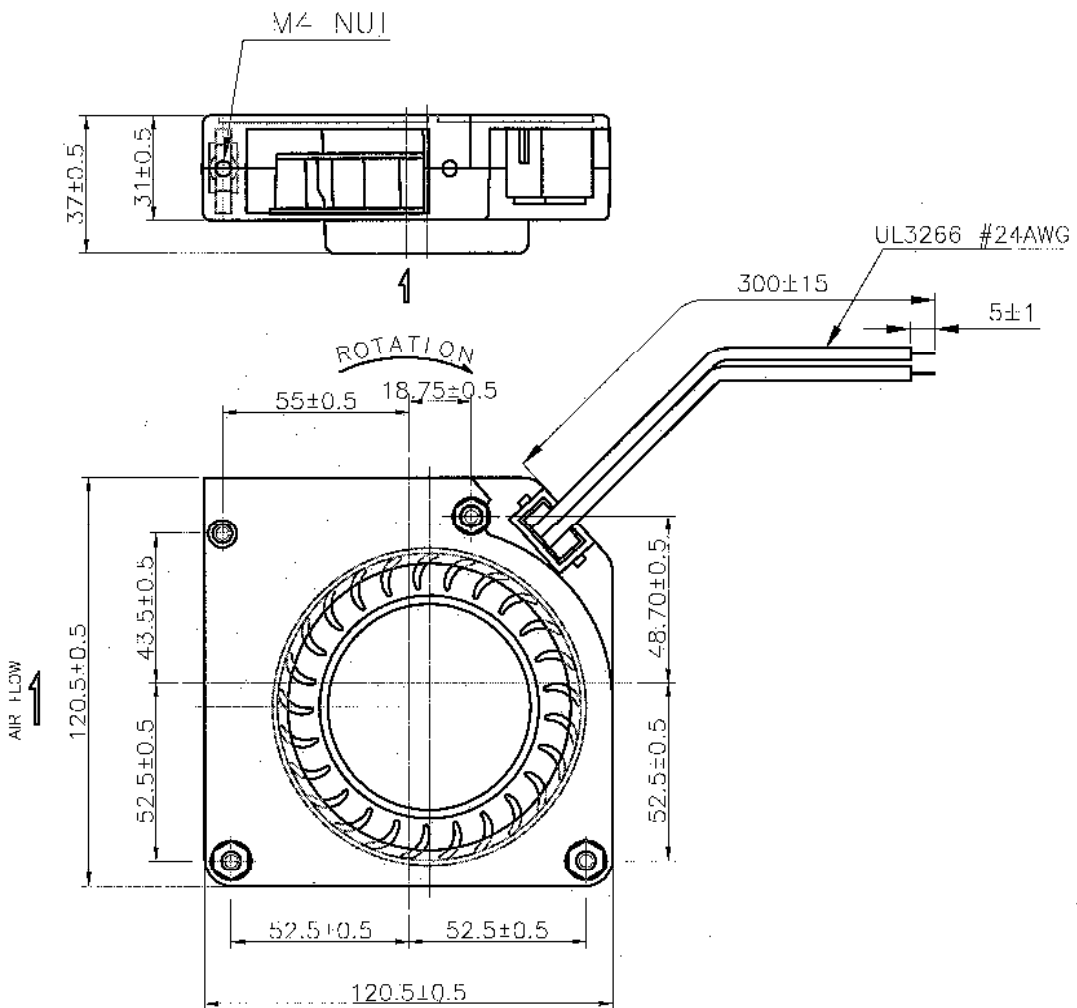
