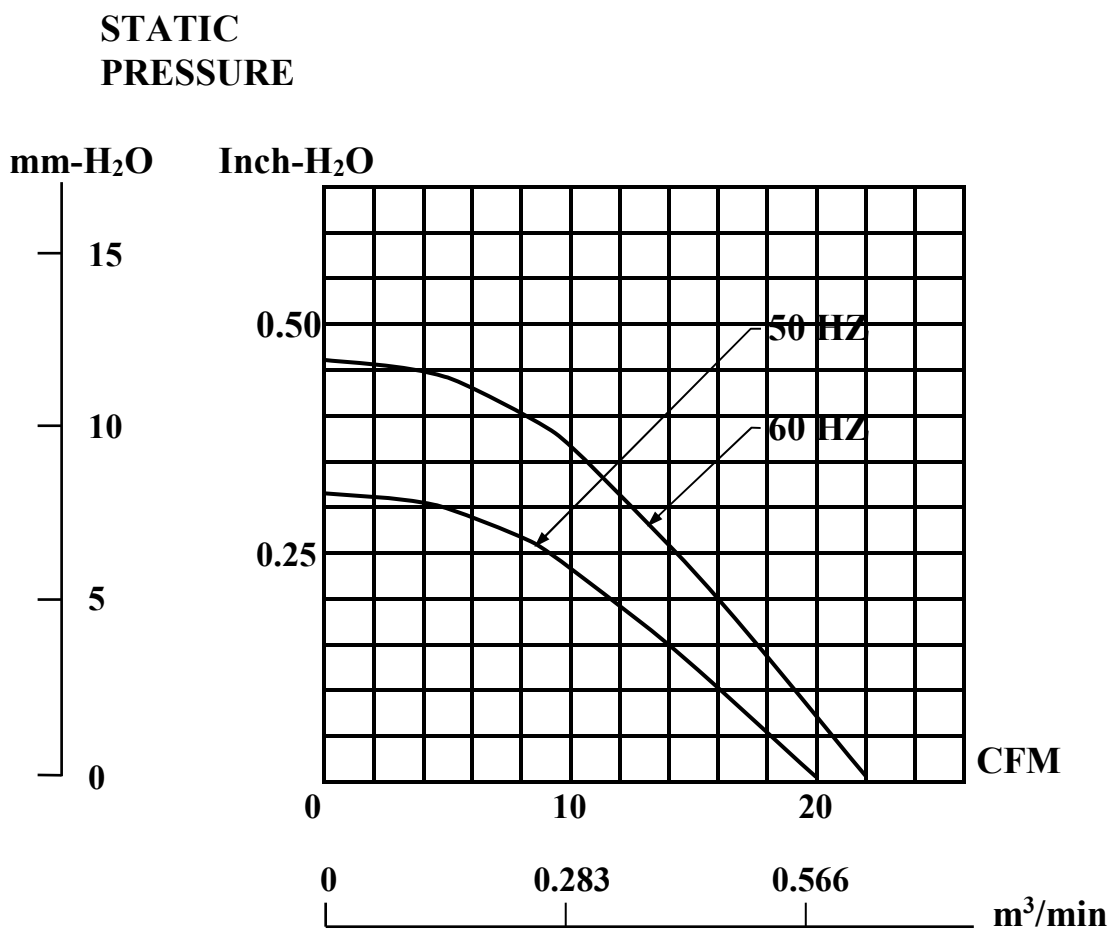

PERFORMANCE CURVES

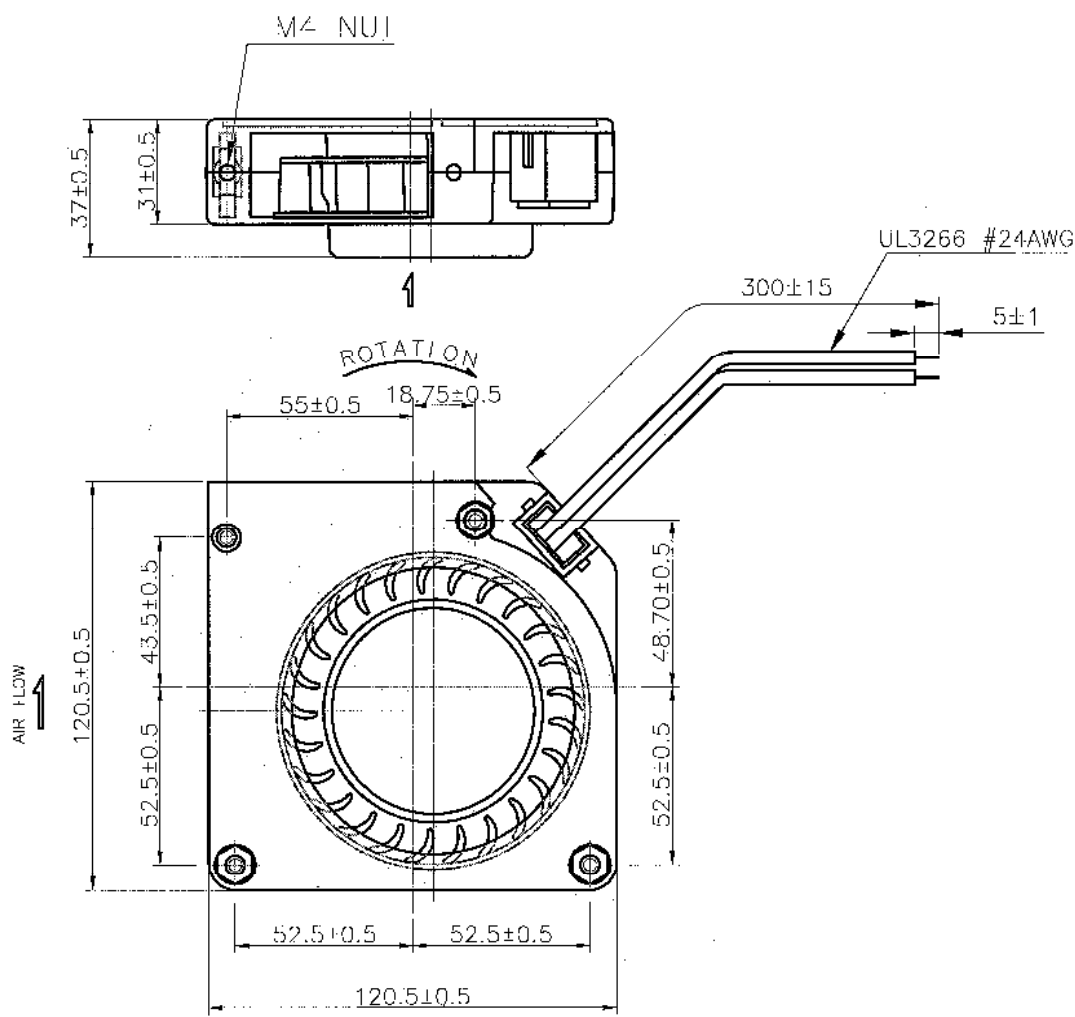
