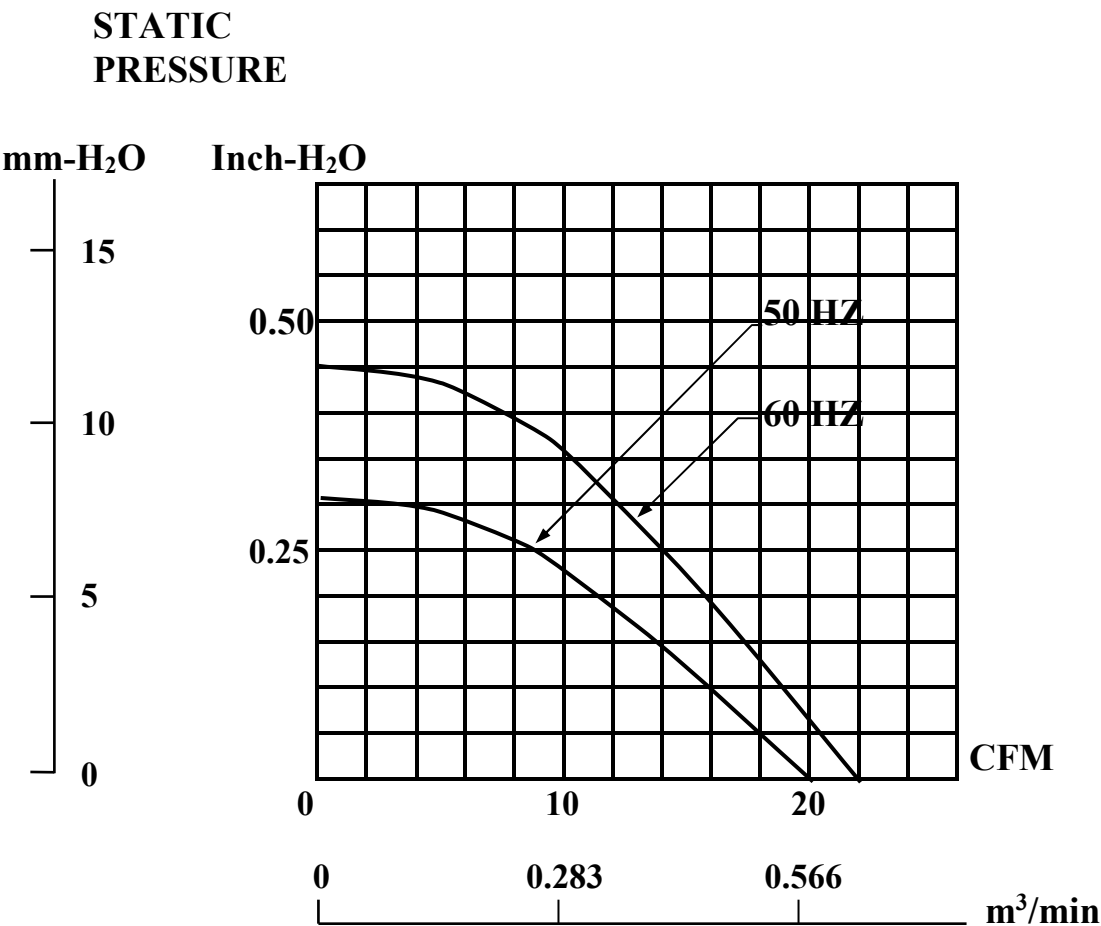

PERFORMANCE CURVES



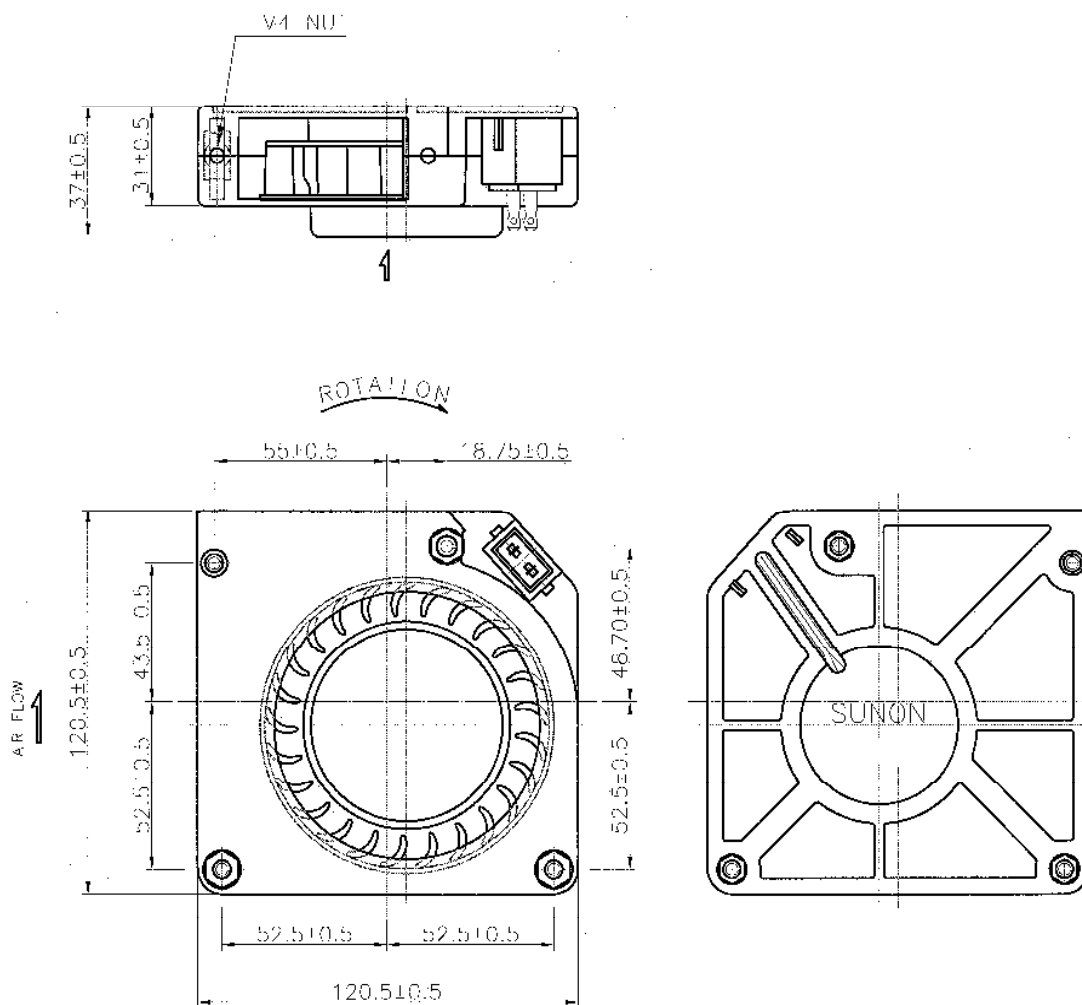
