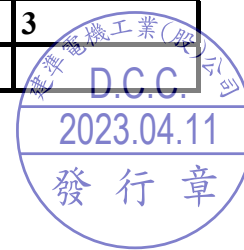

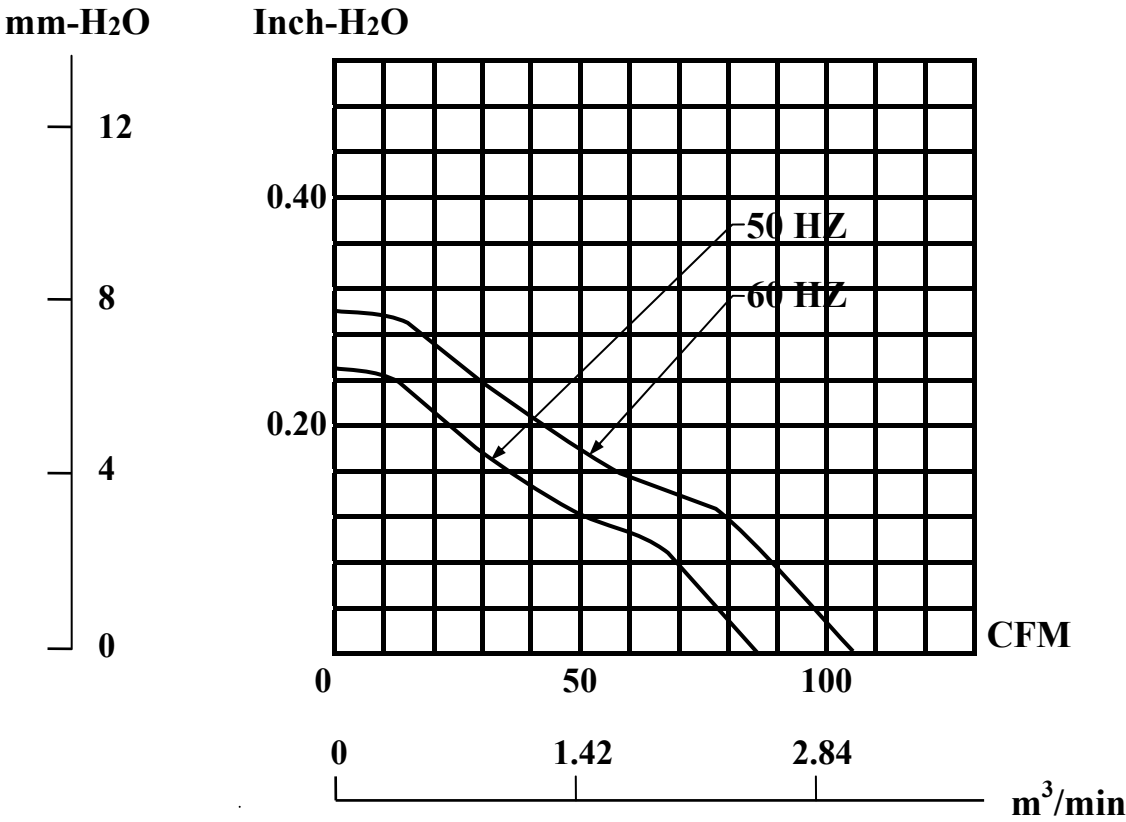

PRESSURE

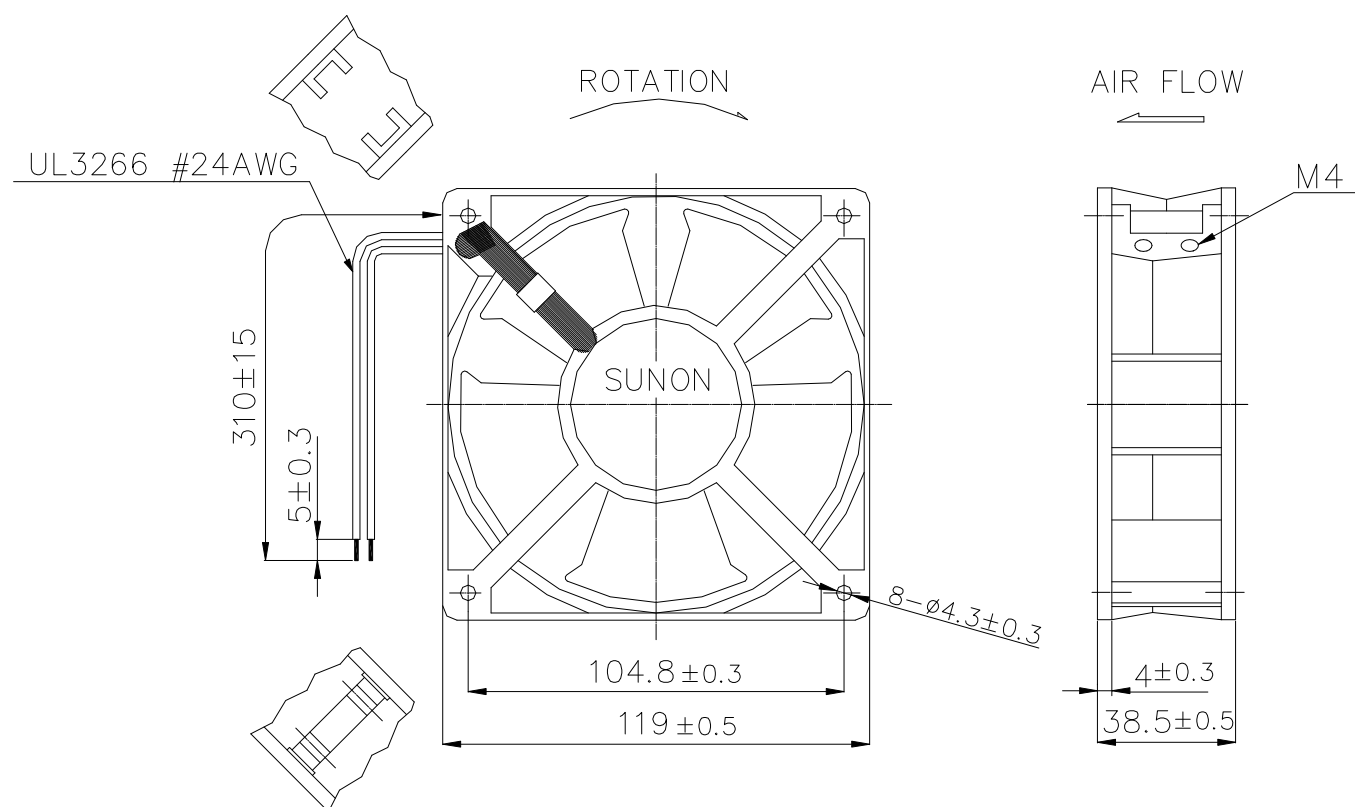
