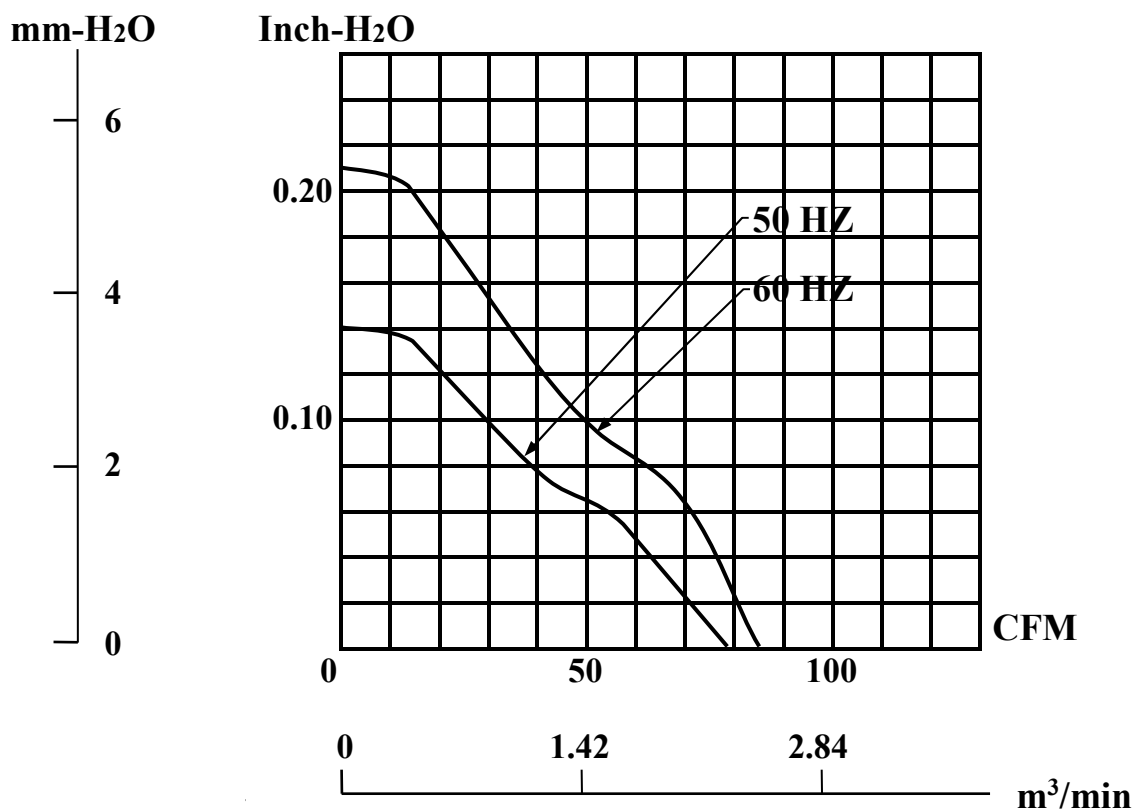

PRESSURE

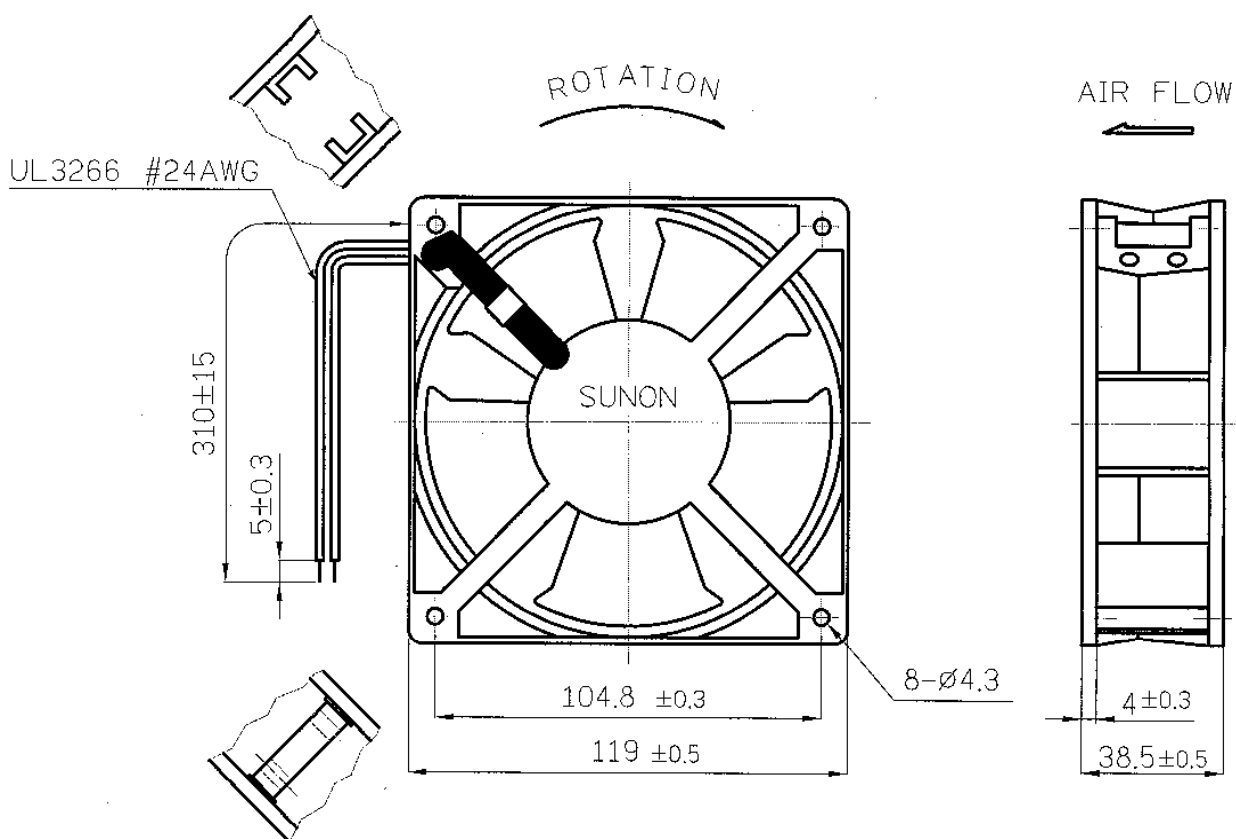
