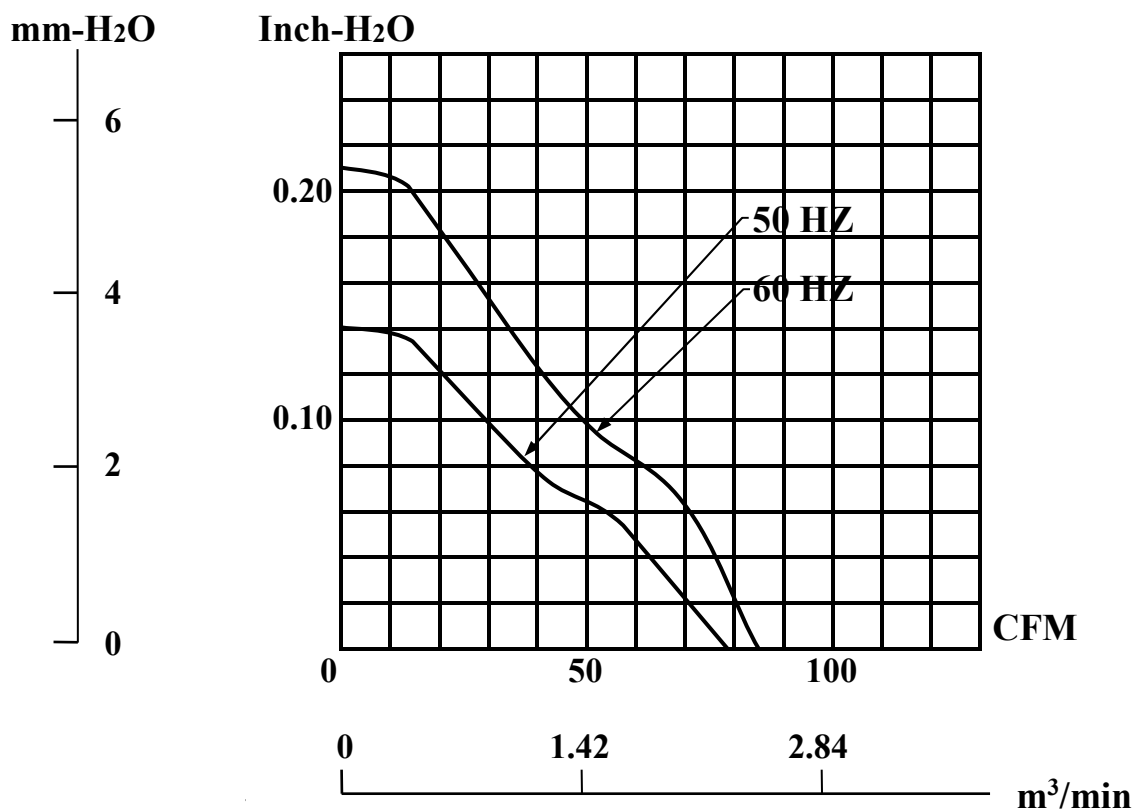

PRESSURE



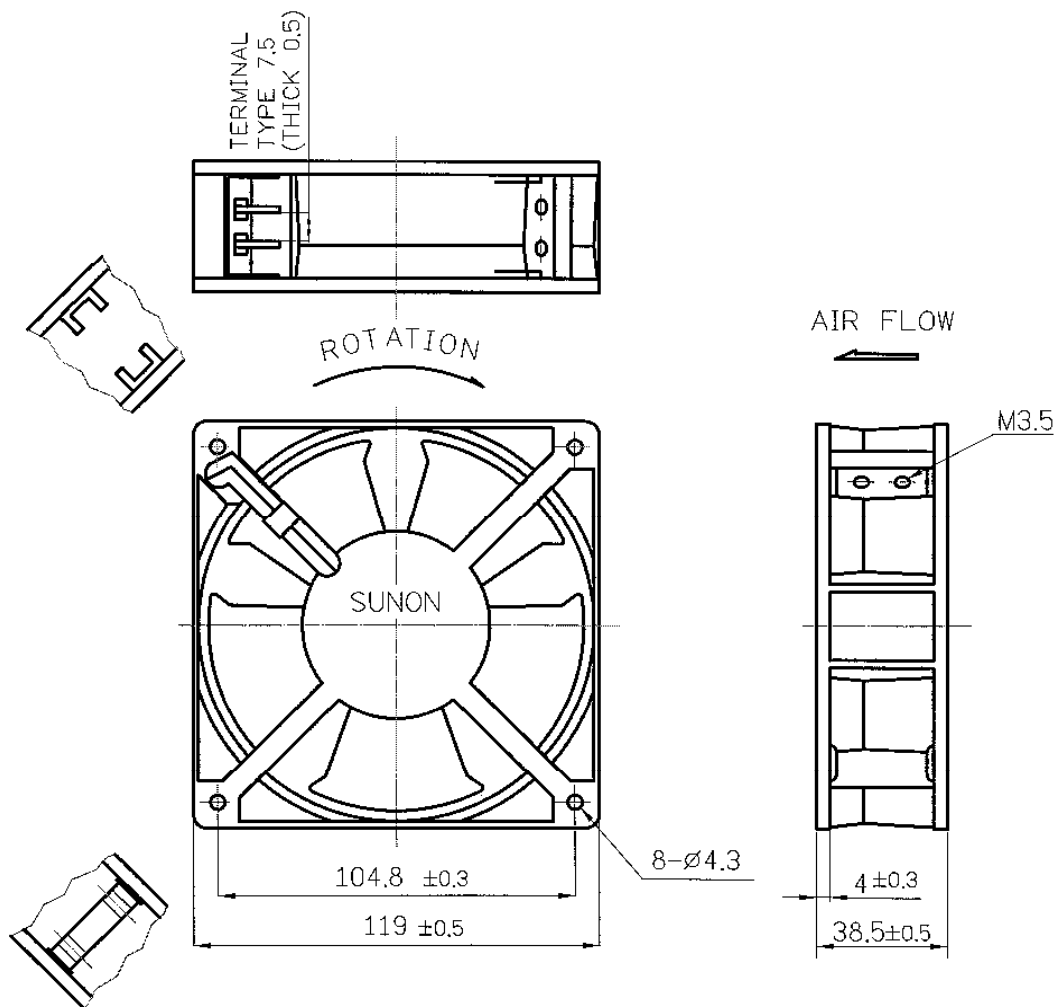
