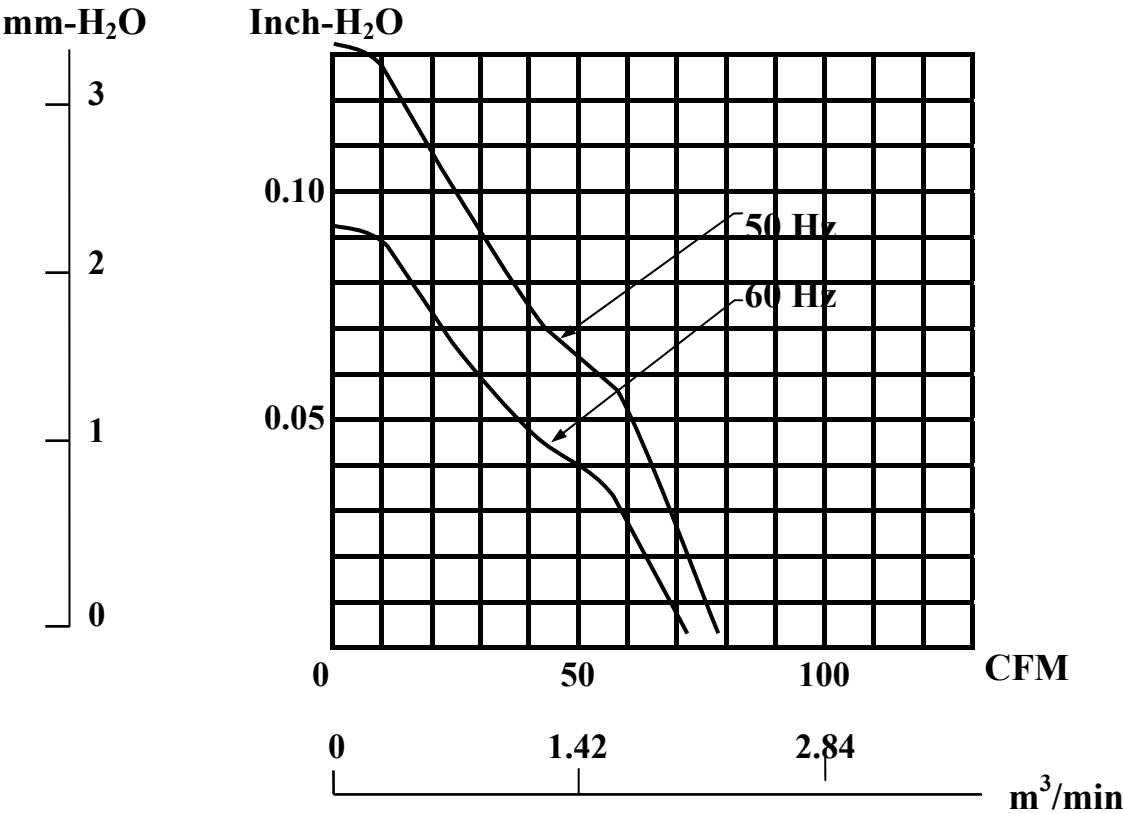

PRESSURE

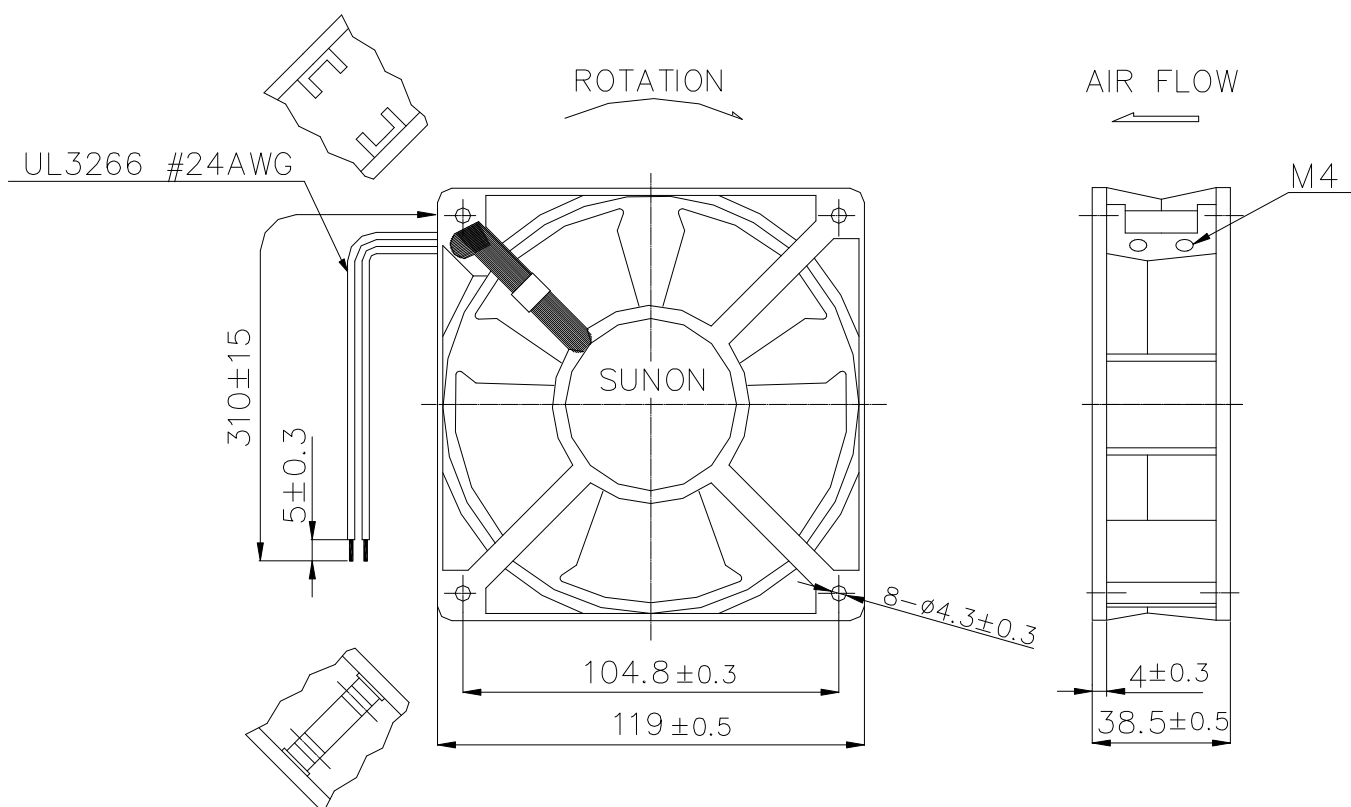
