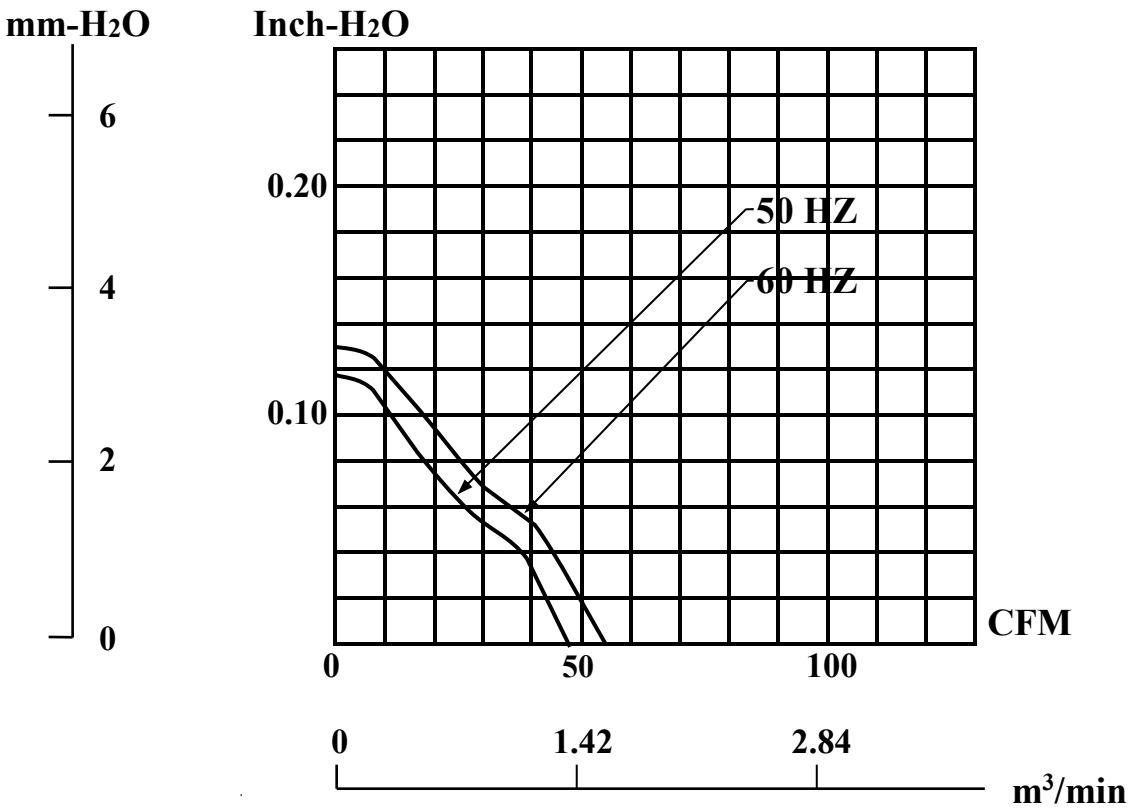

PRESSURE



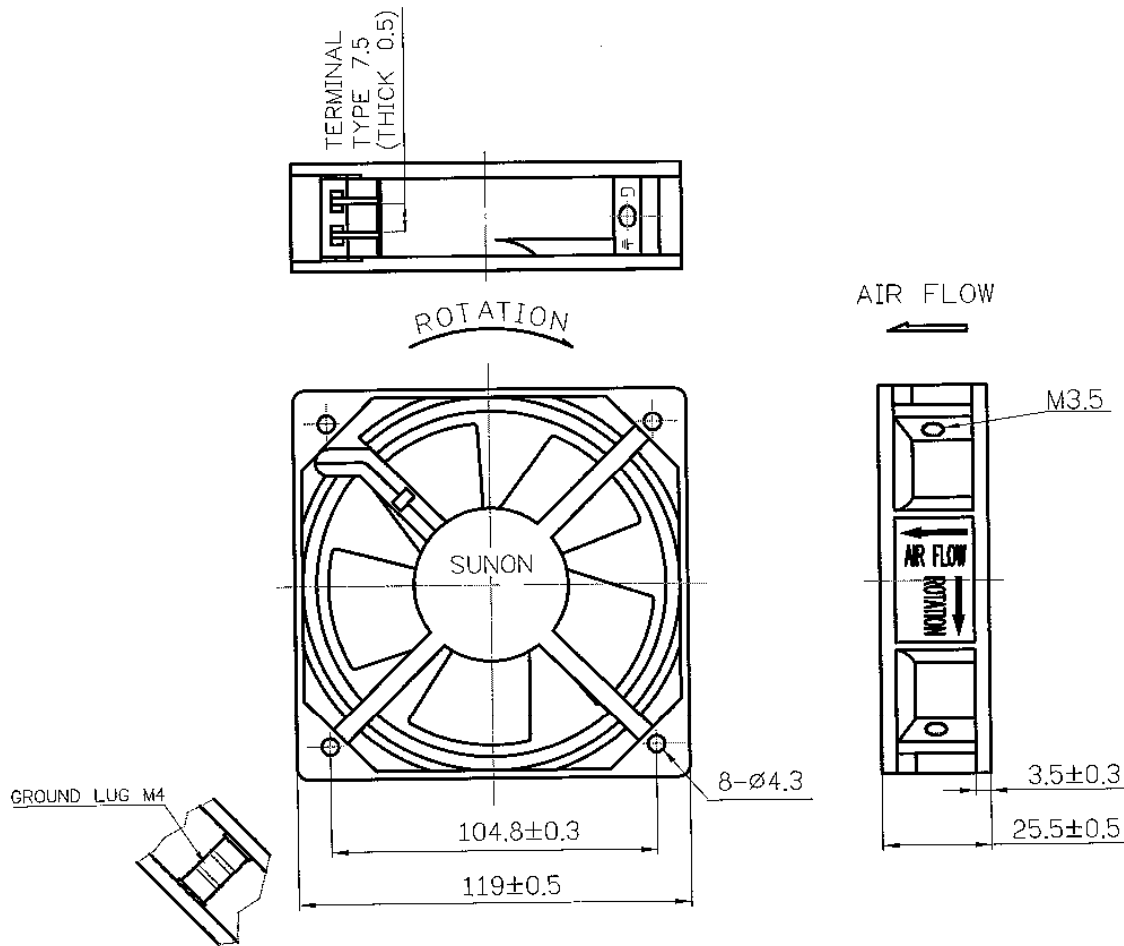
