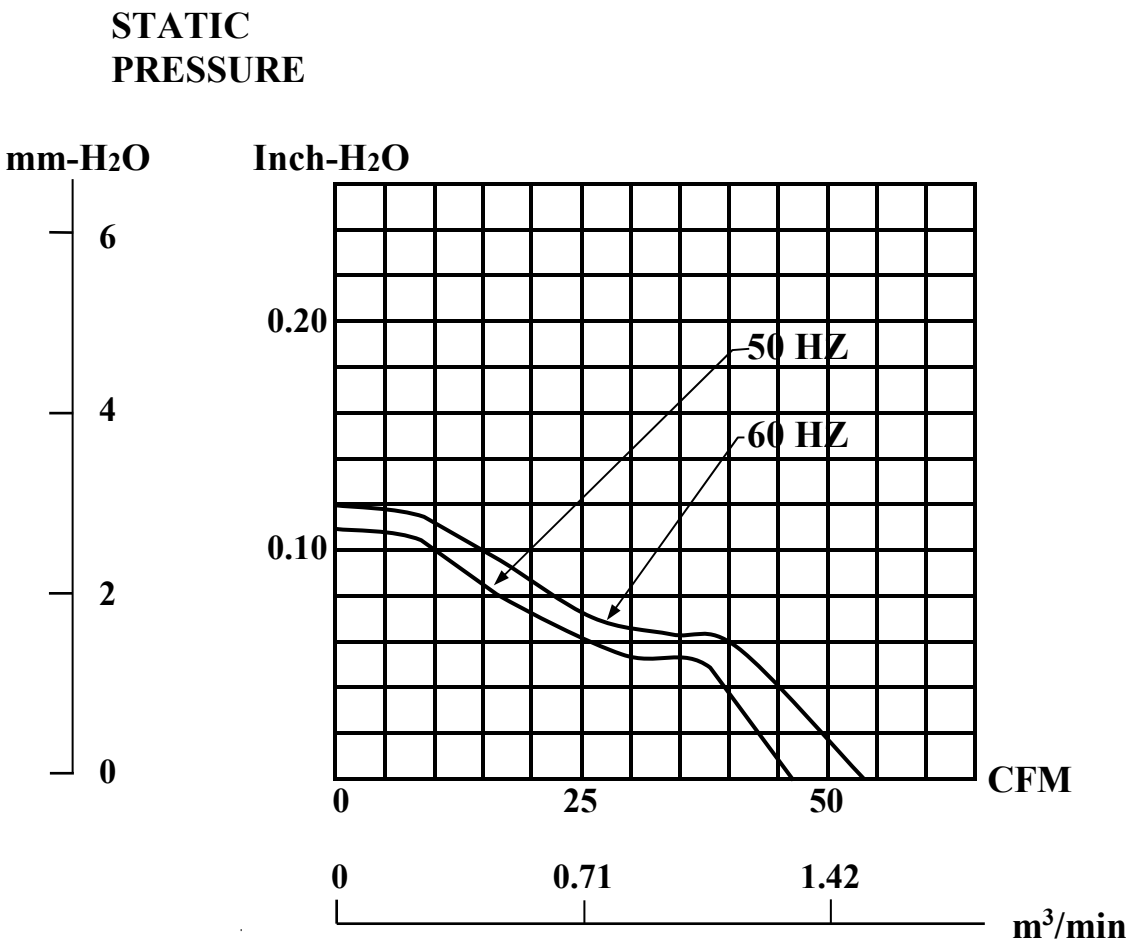

PERFORMANCE CURVES



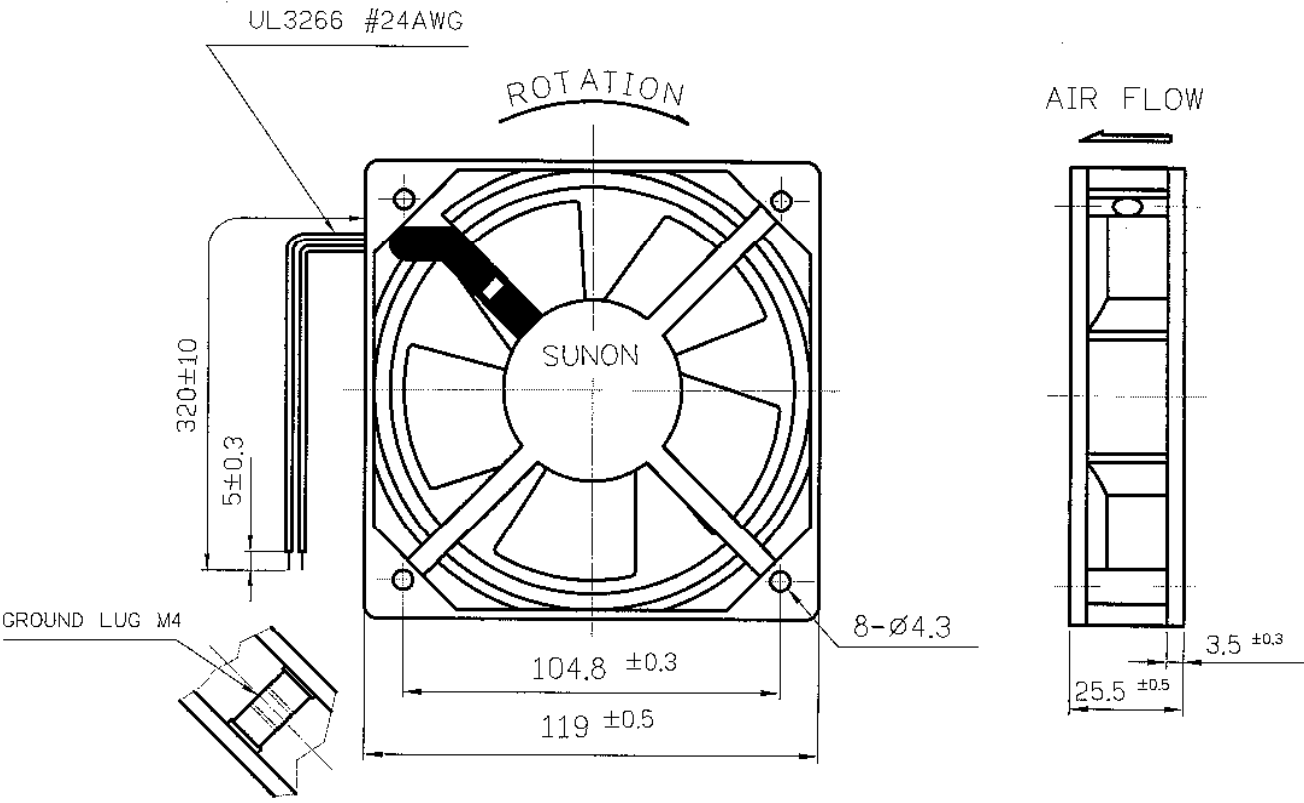
