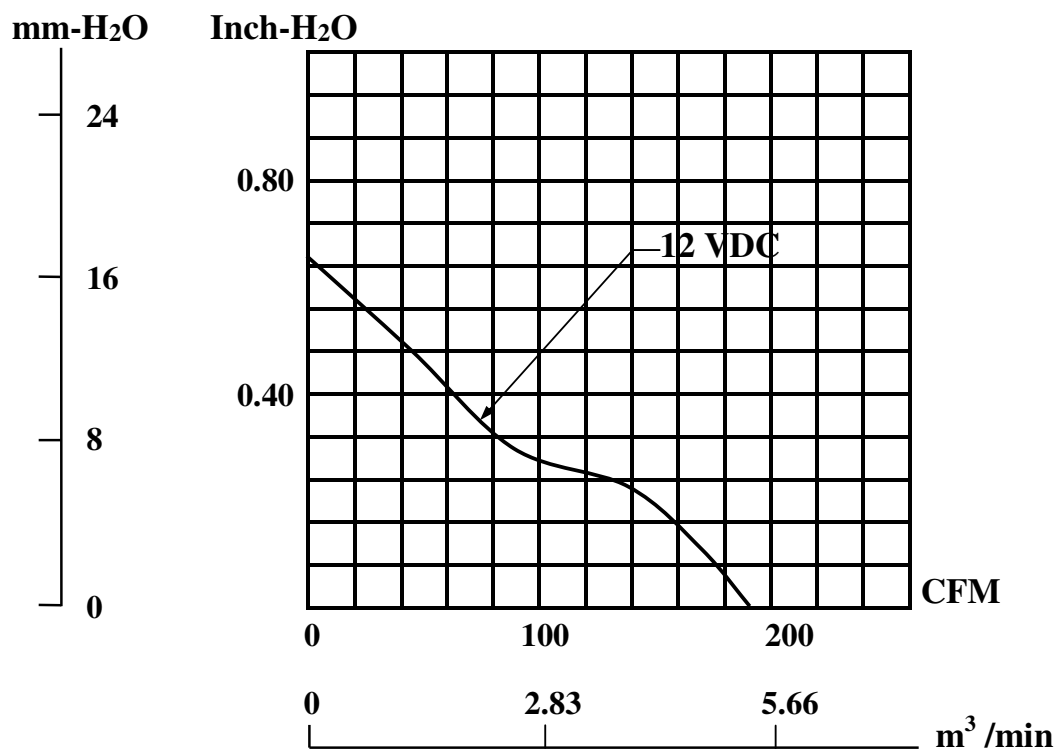

PERFORMANCE CURVES

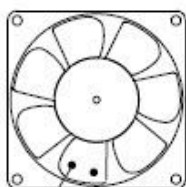

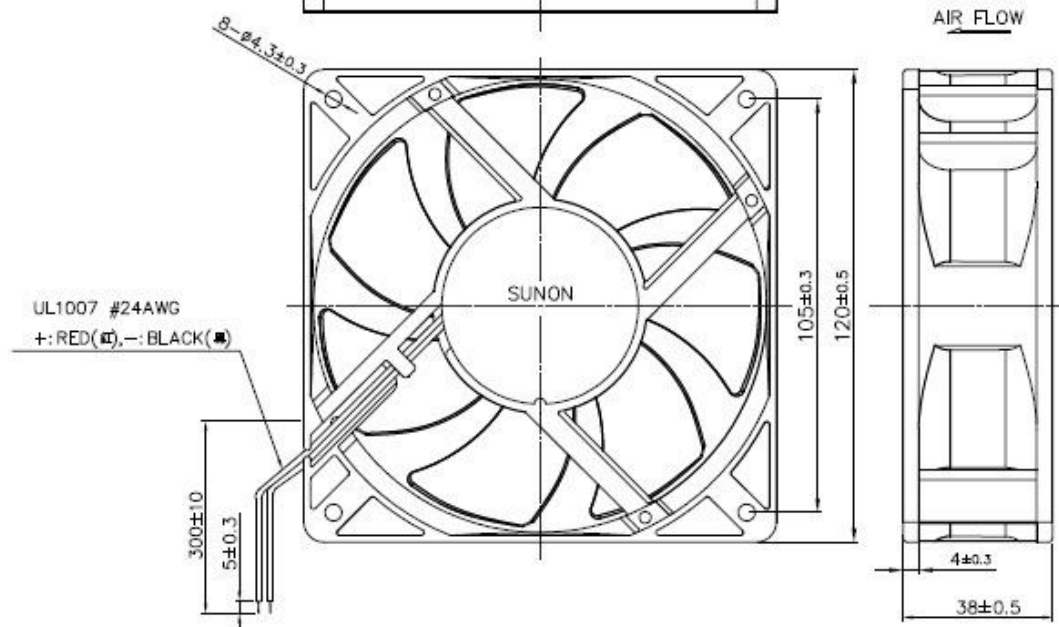
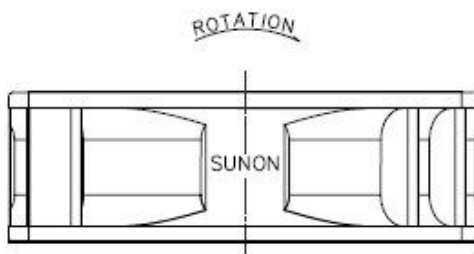
