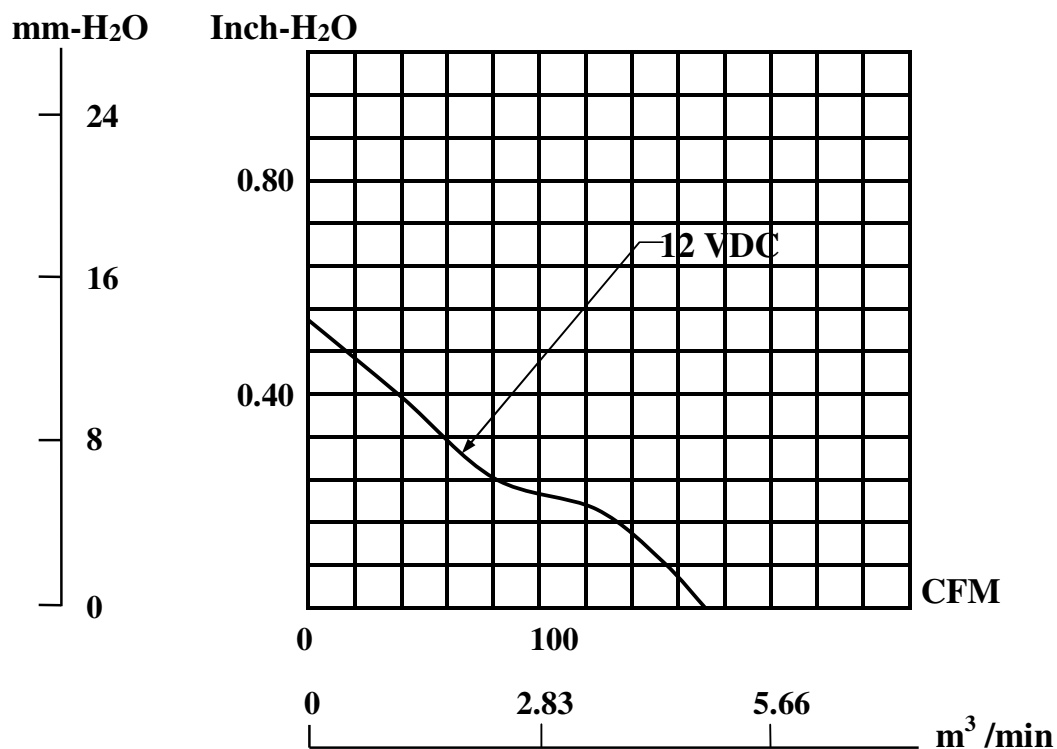

PERFORMANCE CURVES

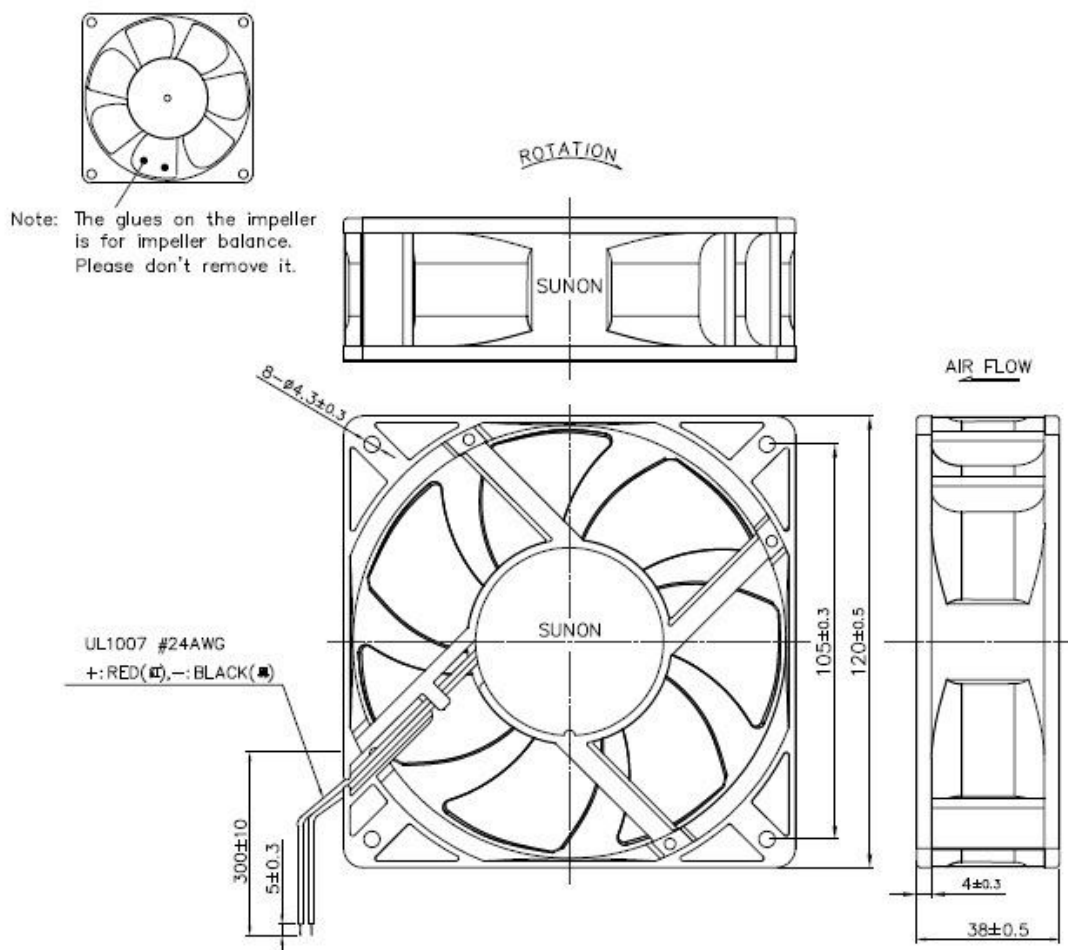
