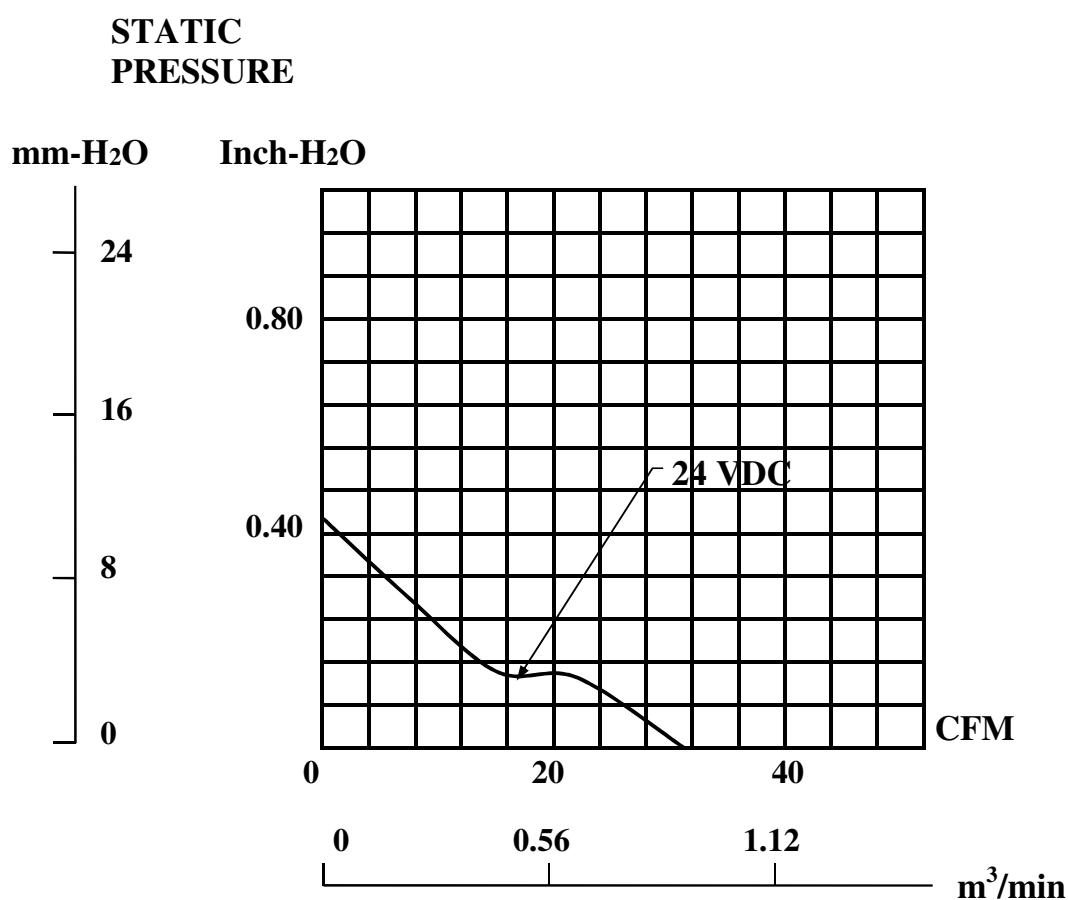

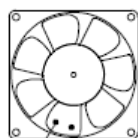
PERFORMANCE CURVES



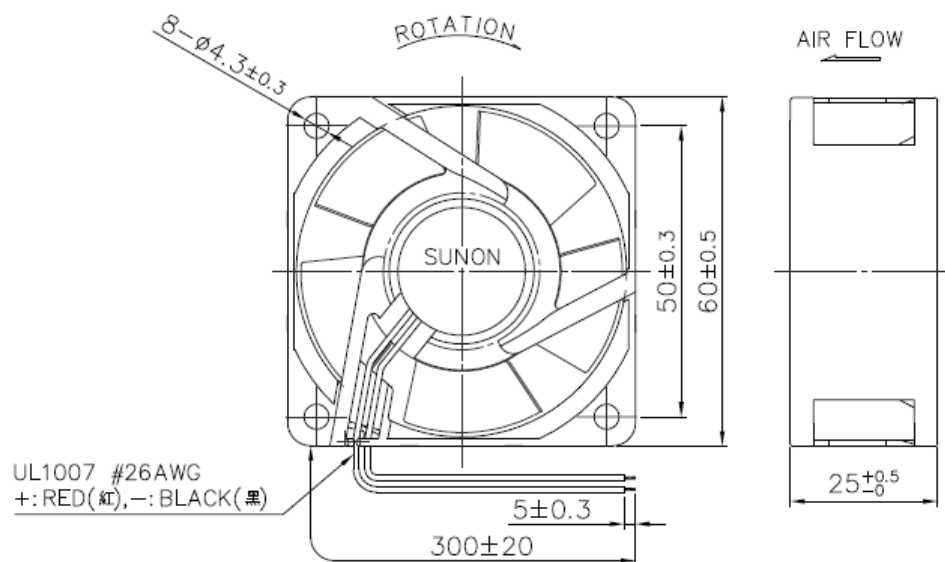
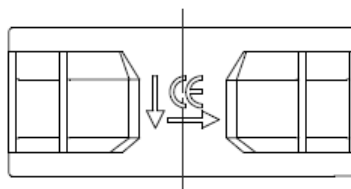
