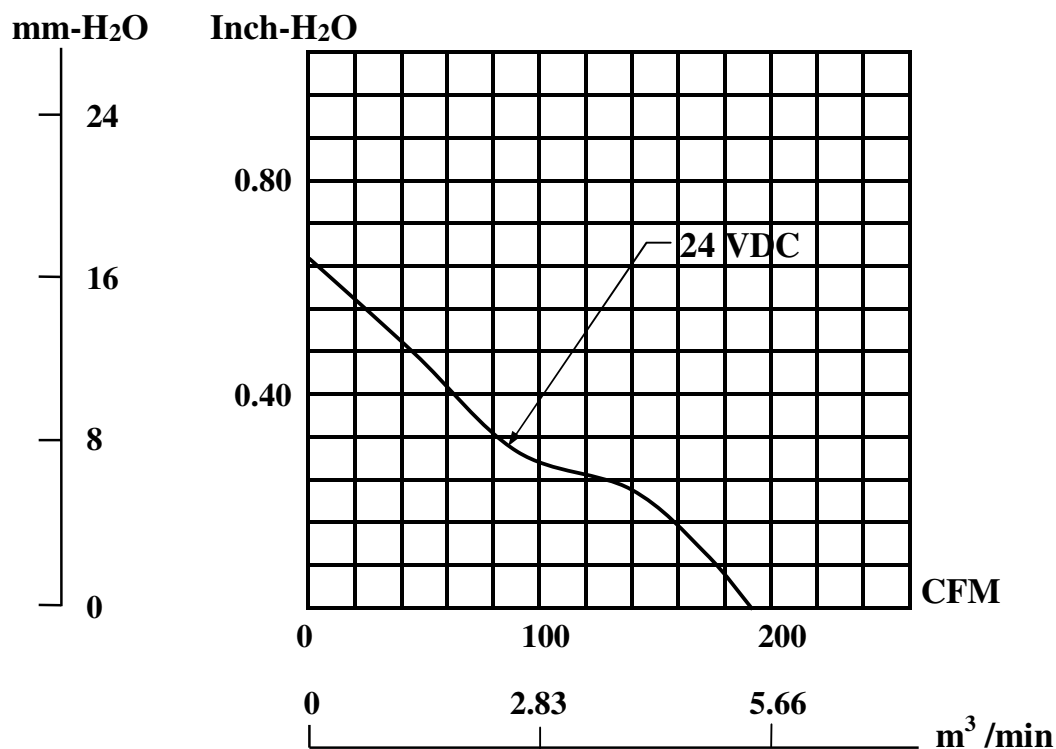

PERFORMANCE CURVES

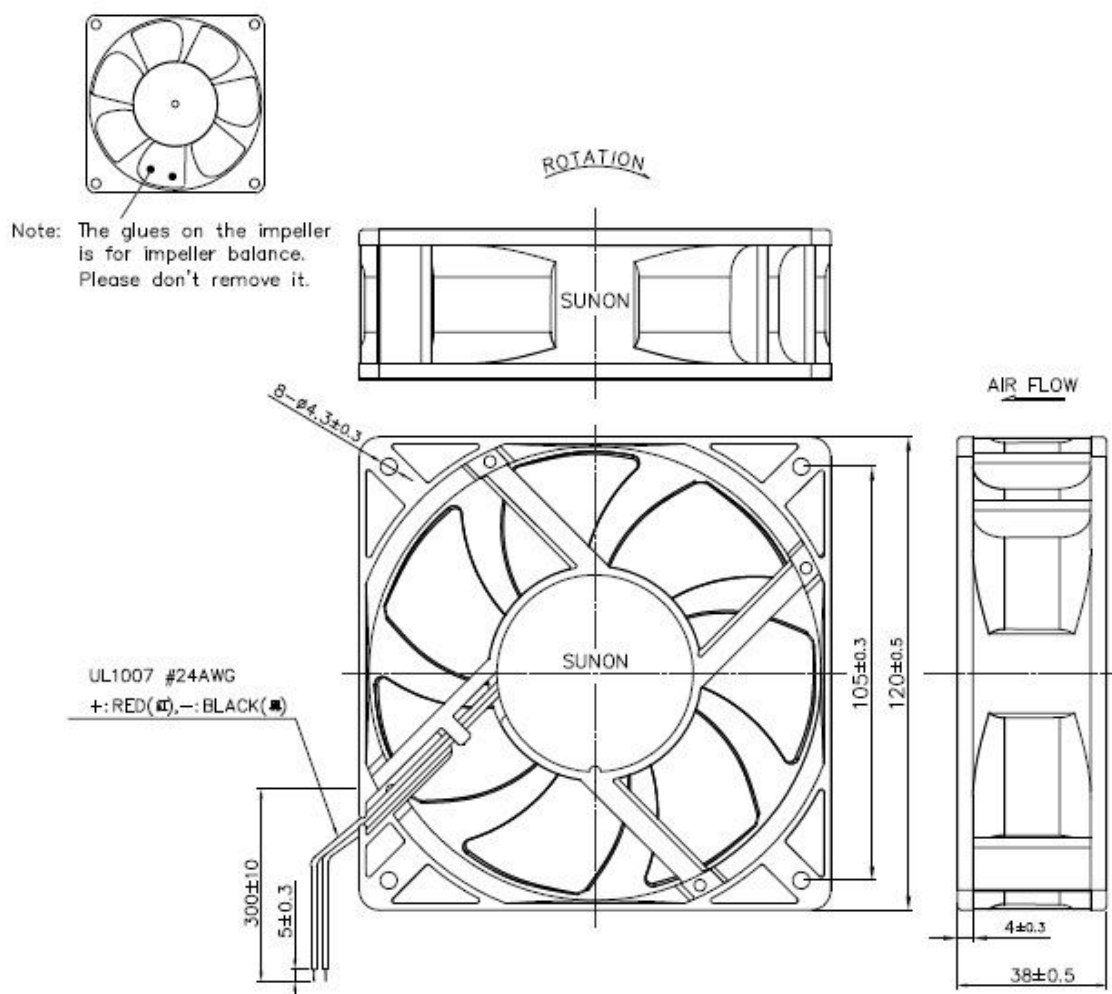
