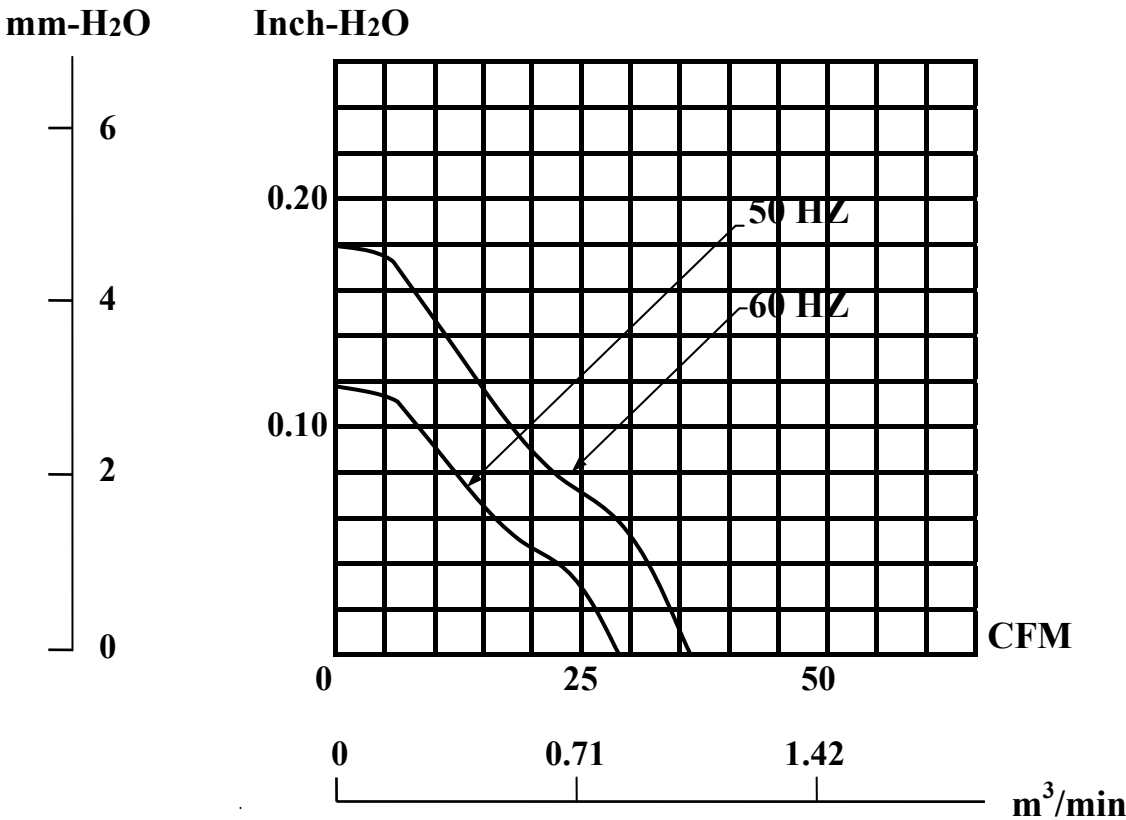

PRESSURE

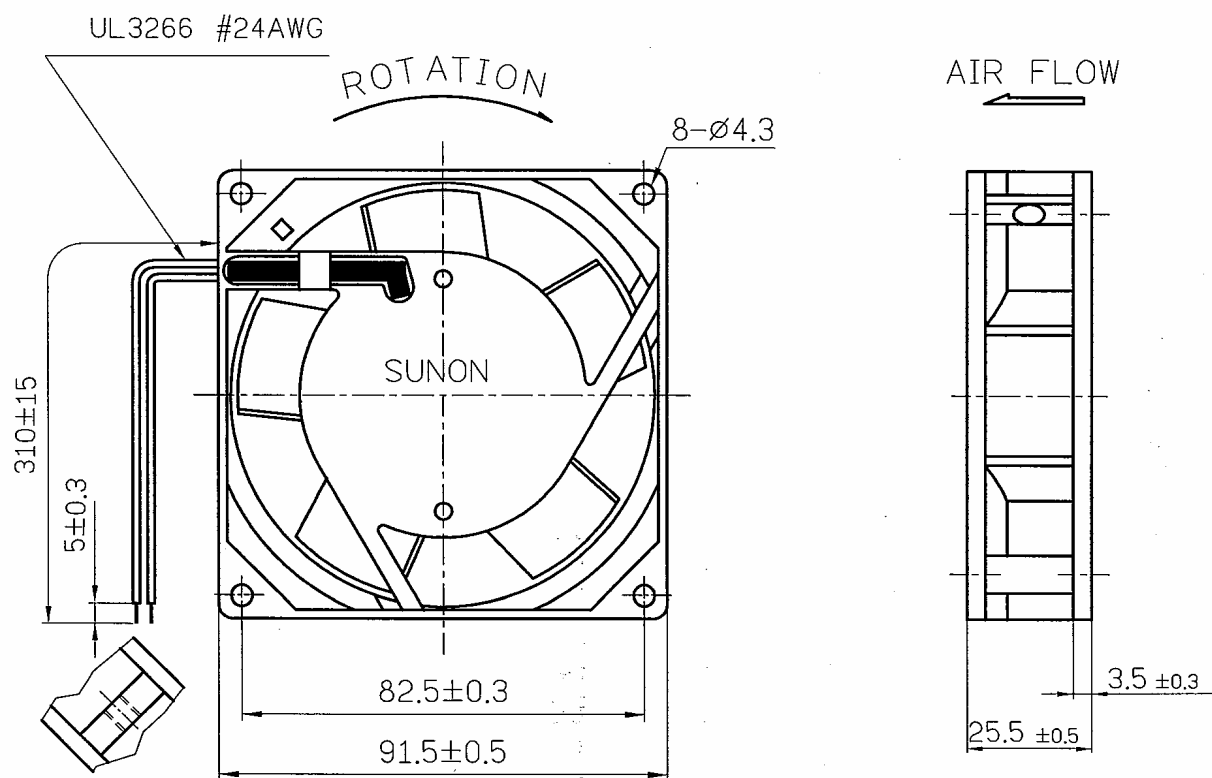
