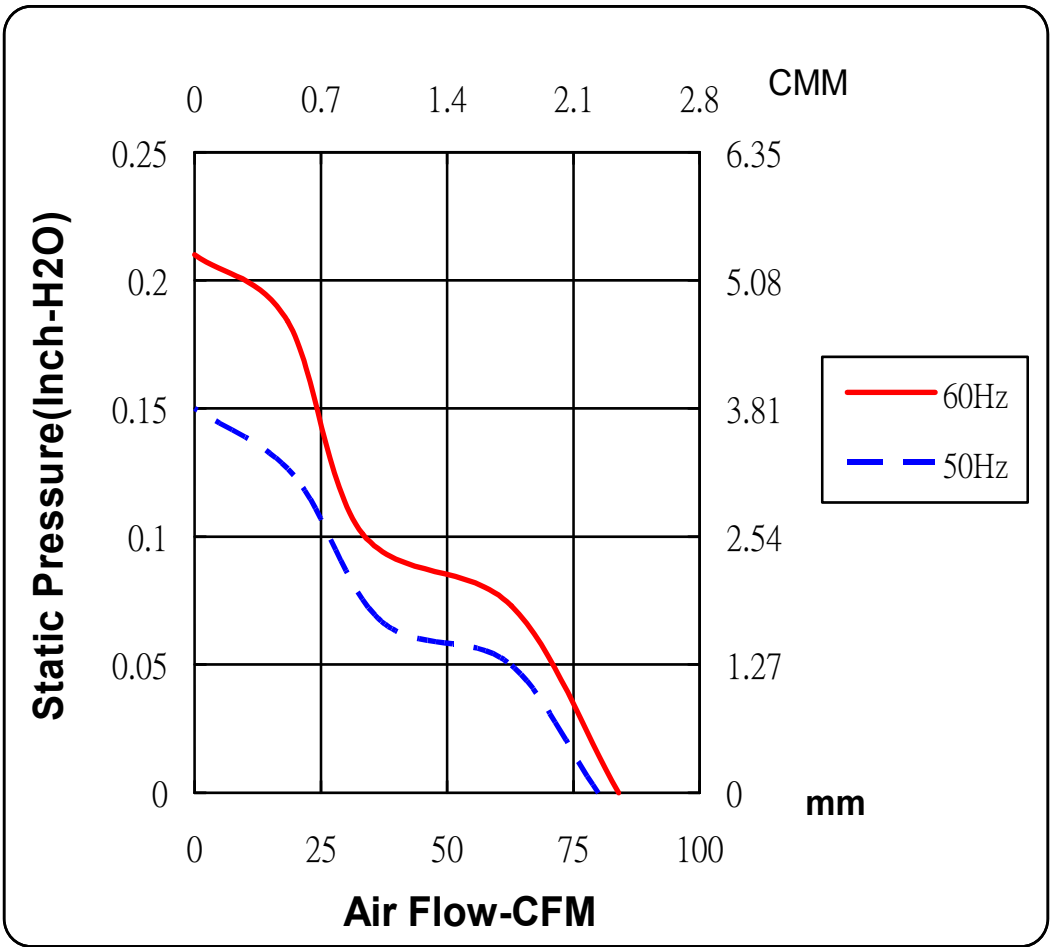

PERFORMANCE CURVES



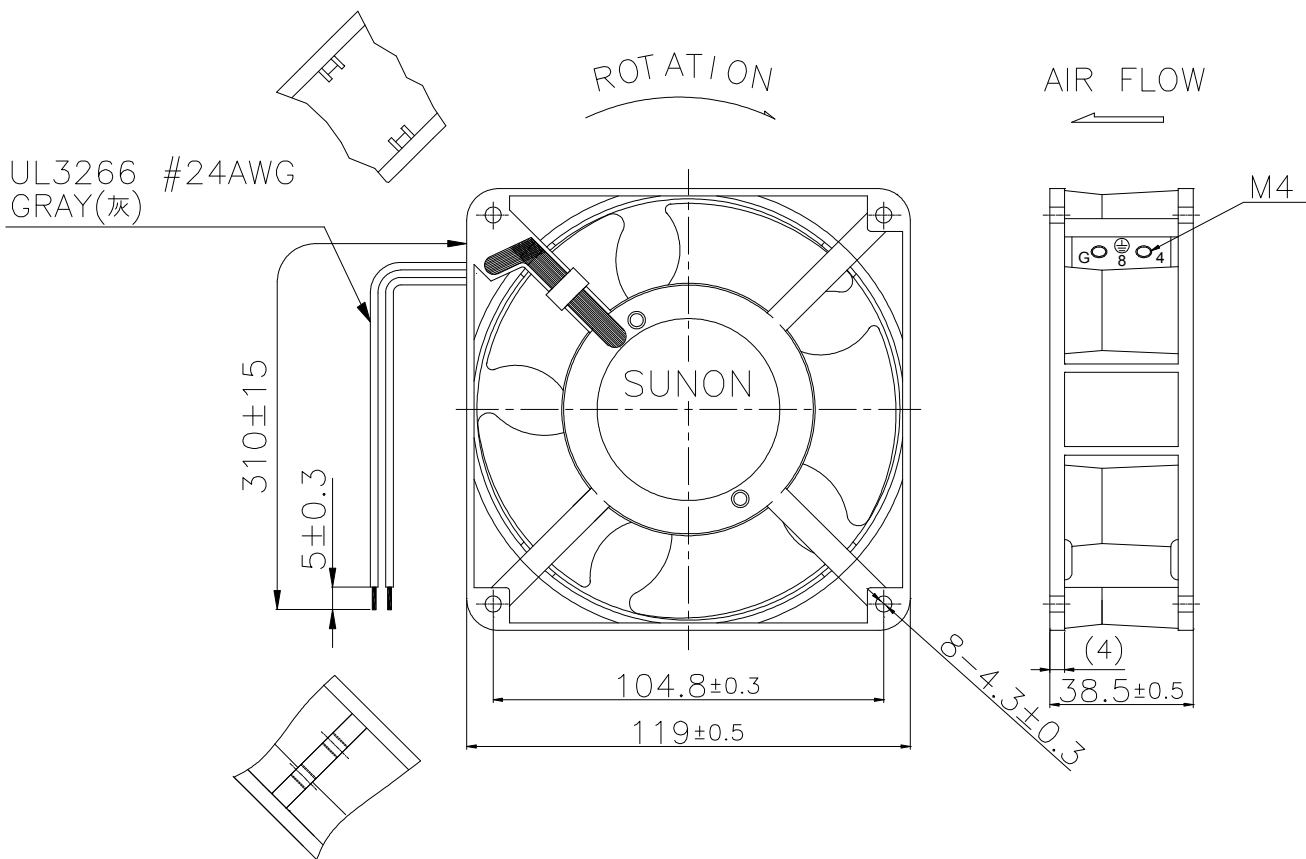
