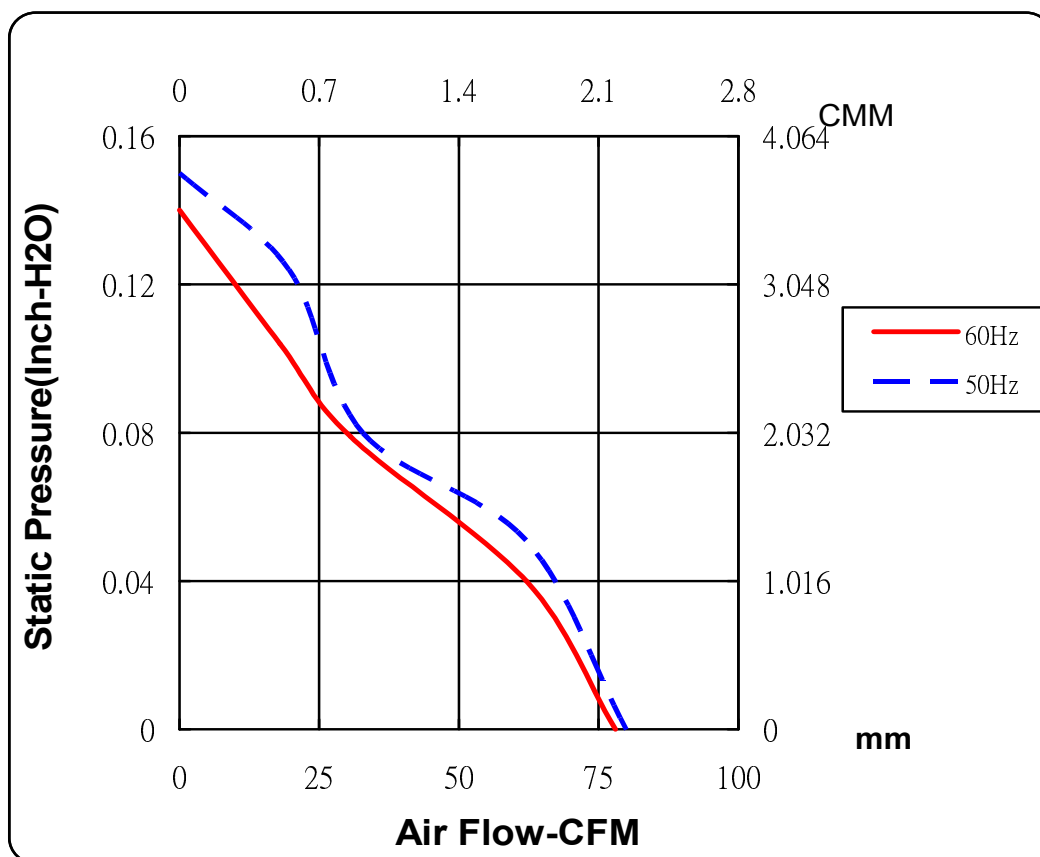

PERFORMANCE CURVES



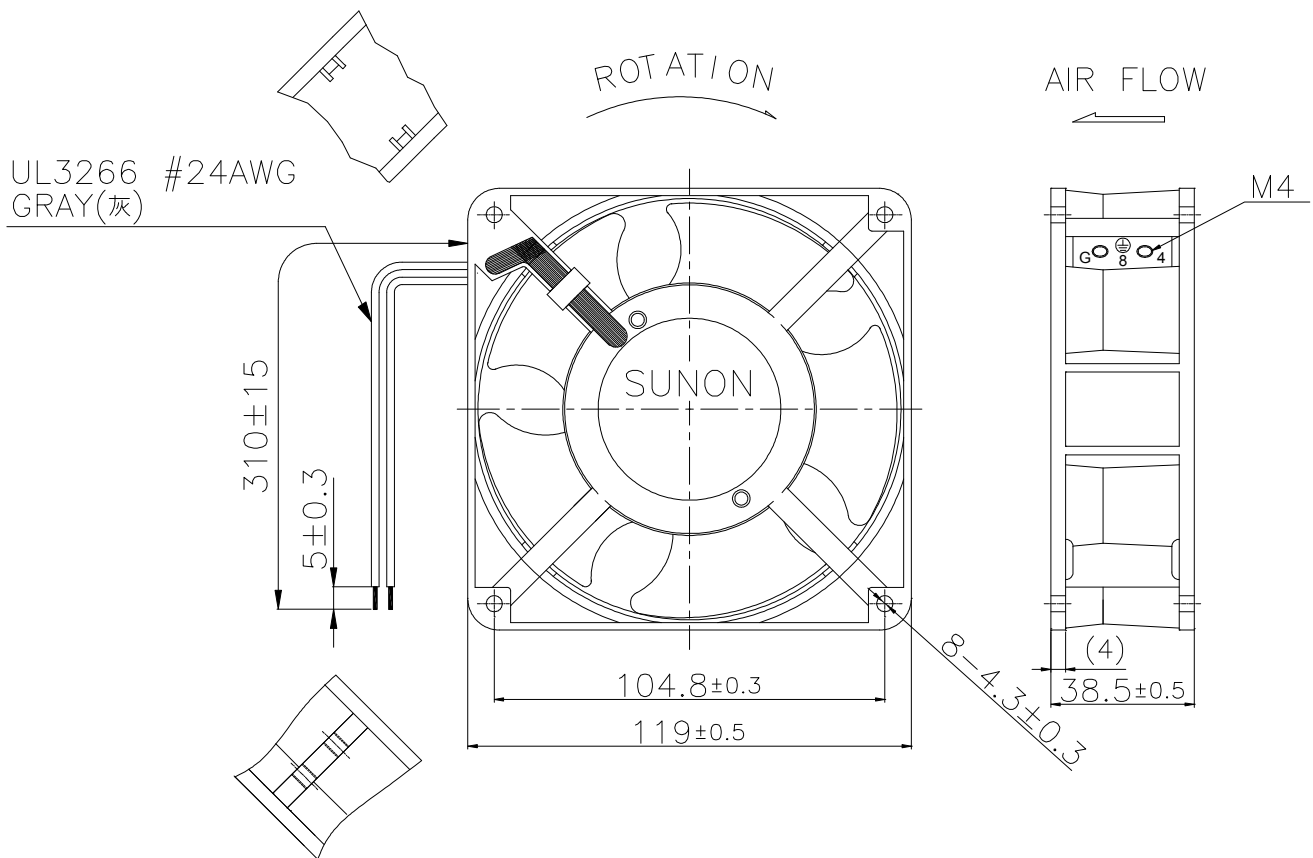
