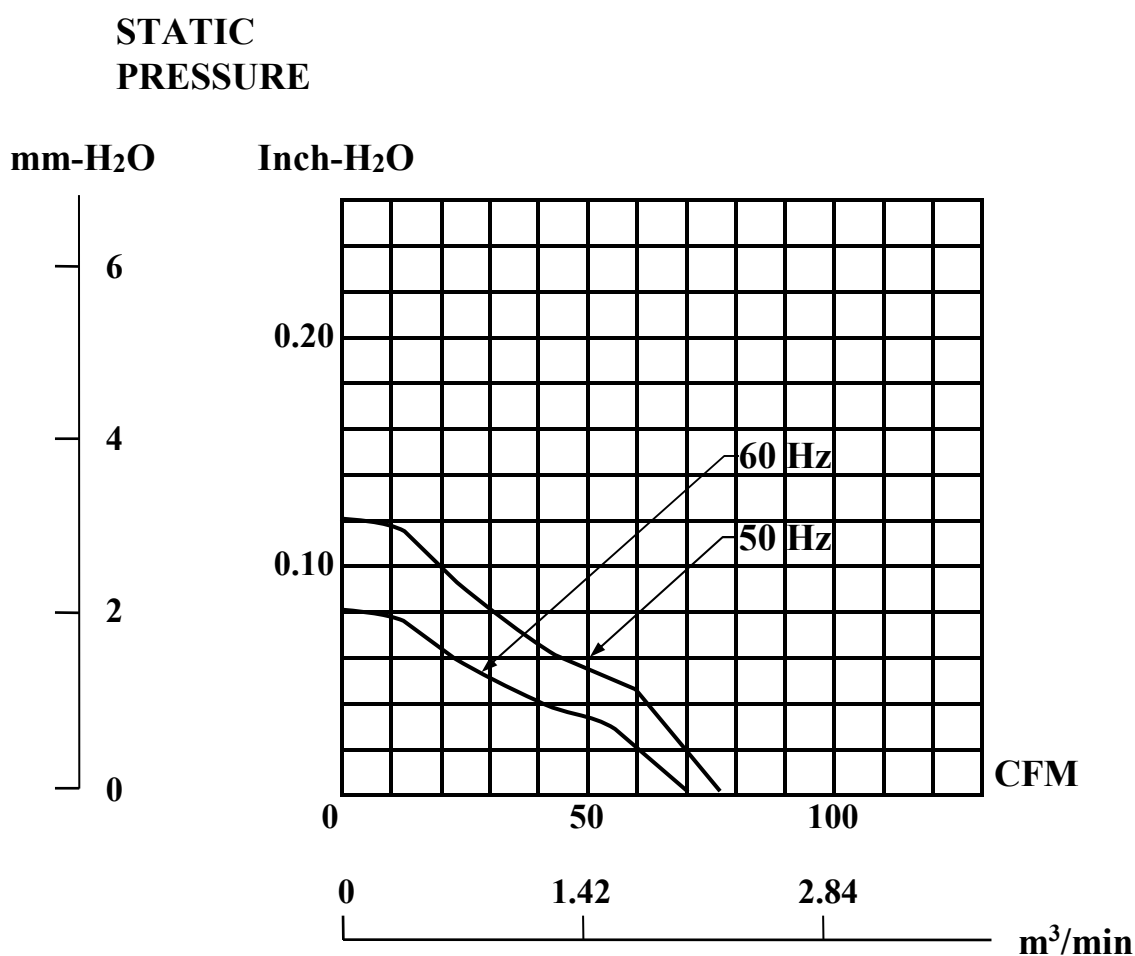

PERFORMANCE CURVES

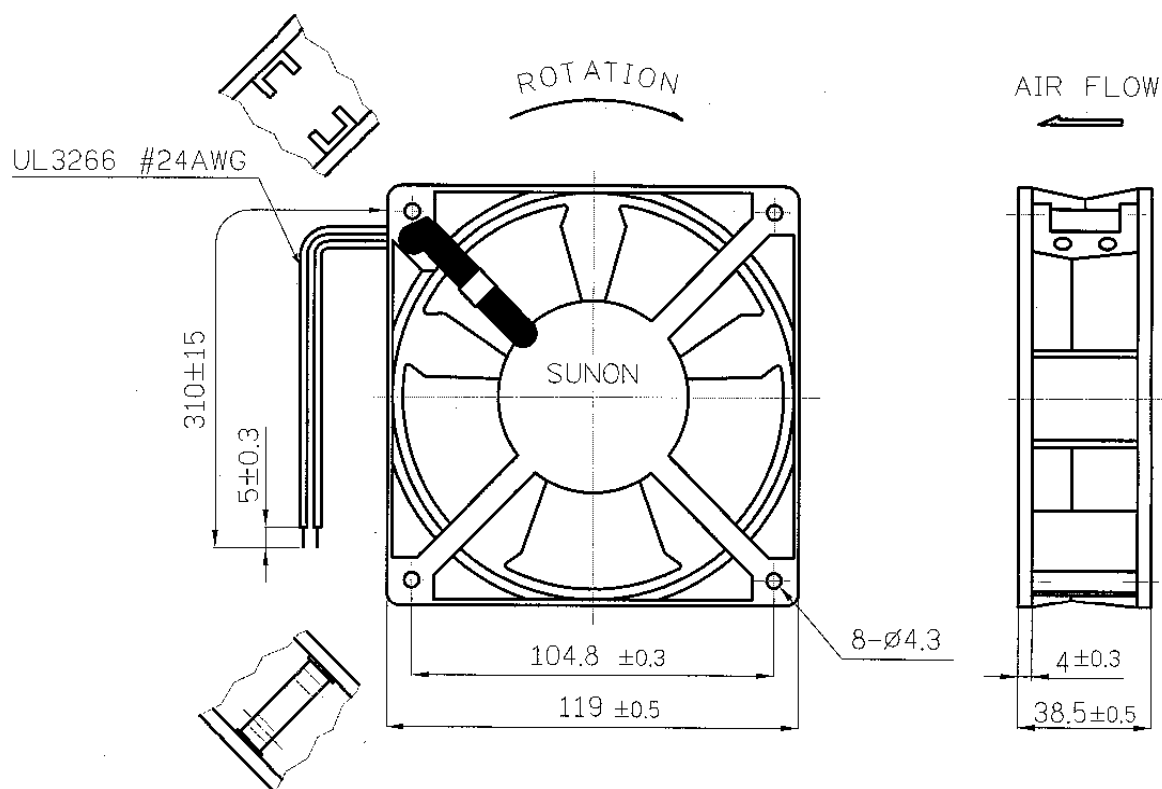
