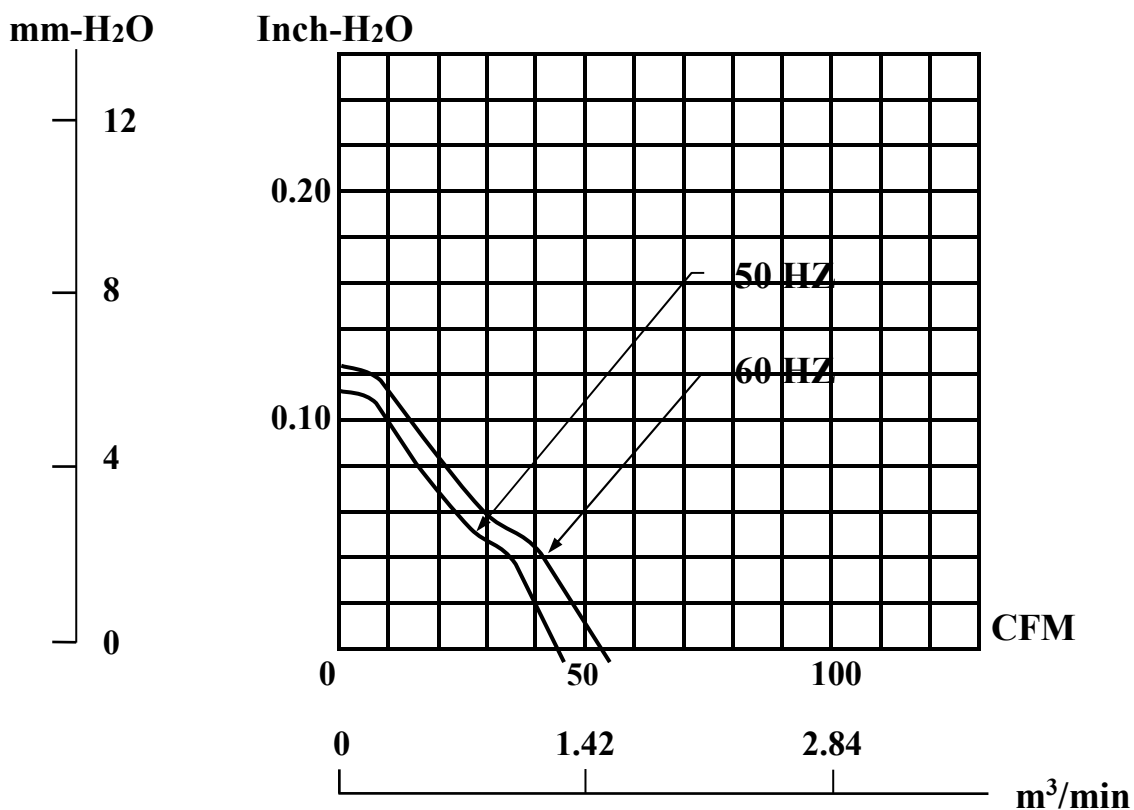

PRESSURE**



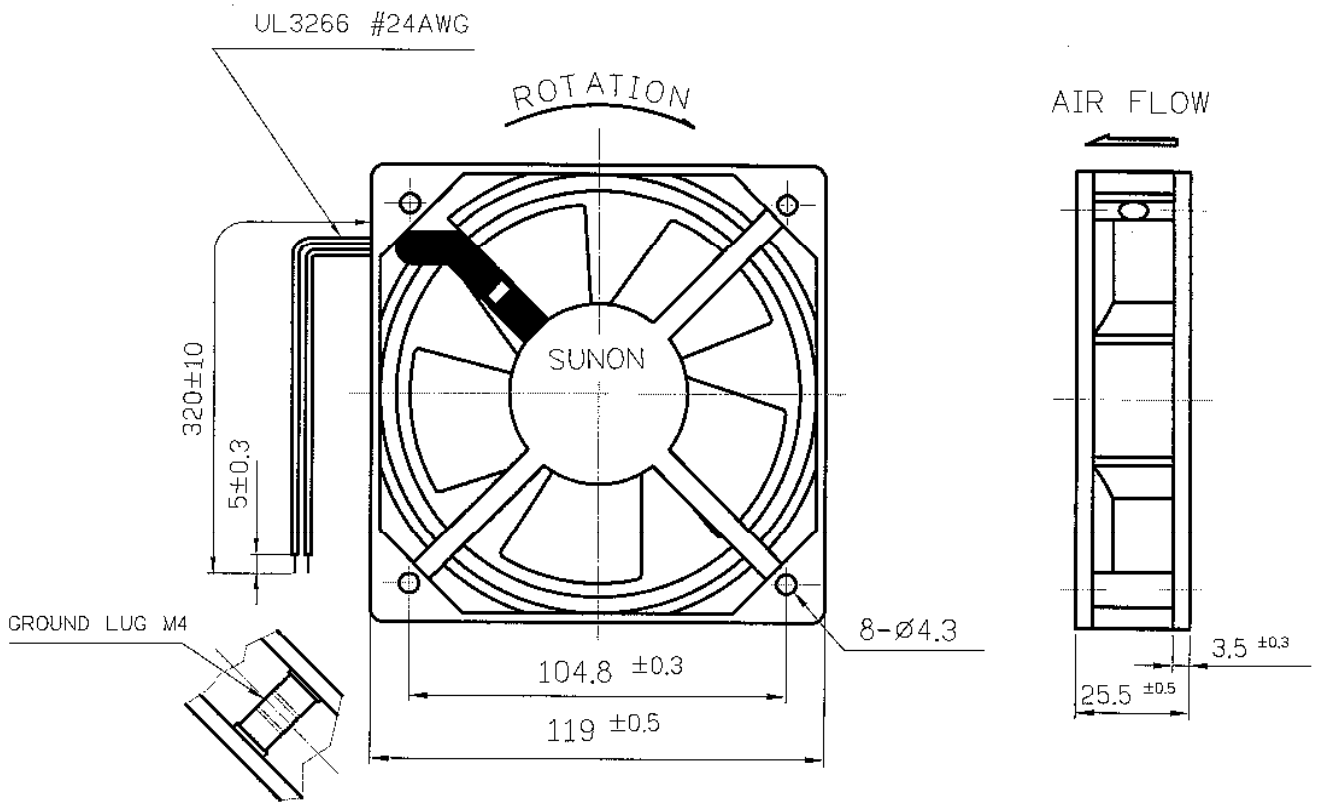
