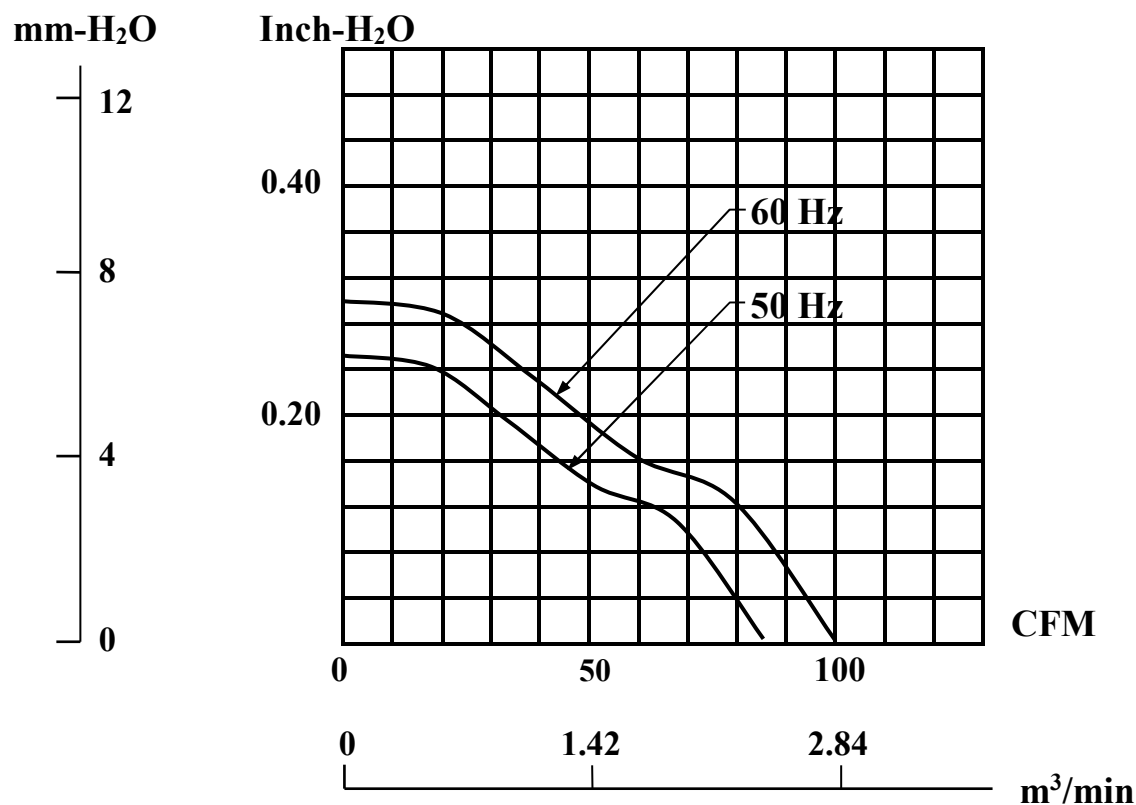

PRESSURE**

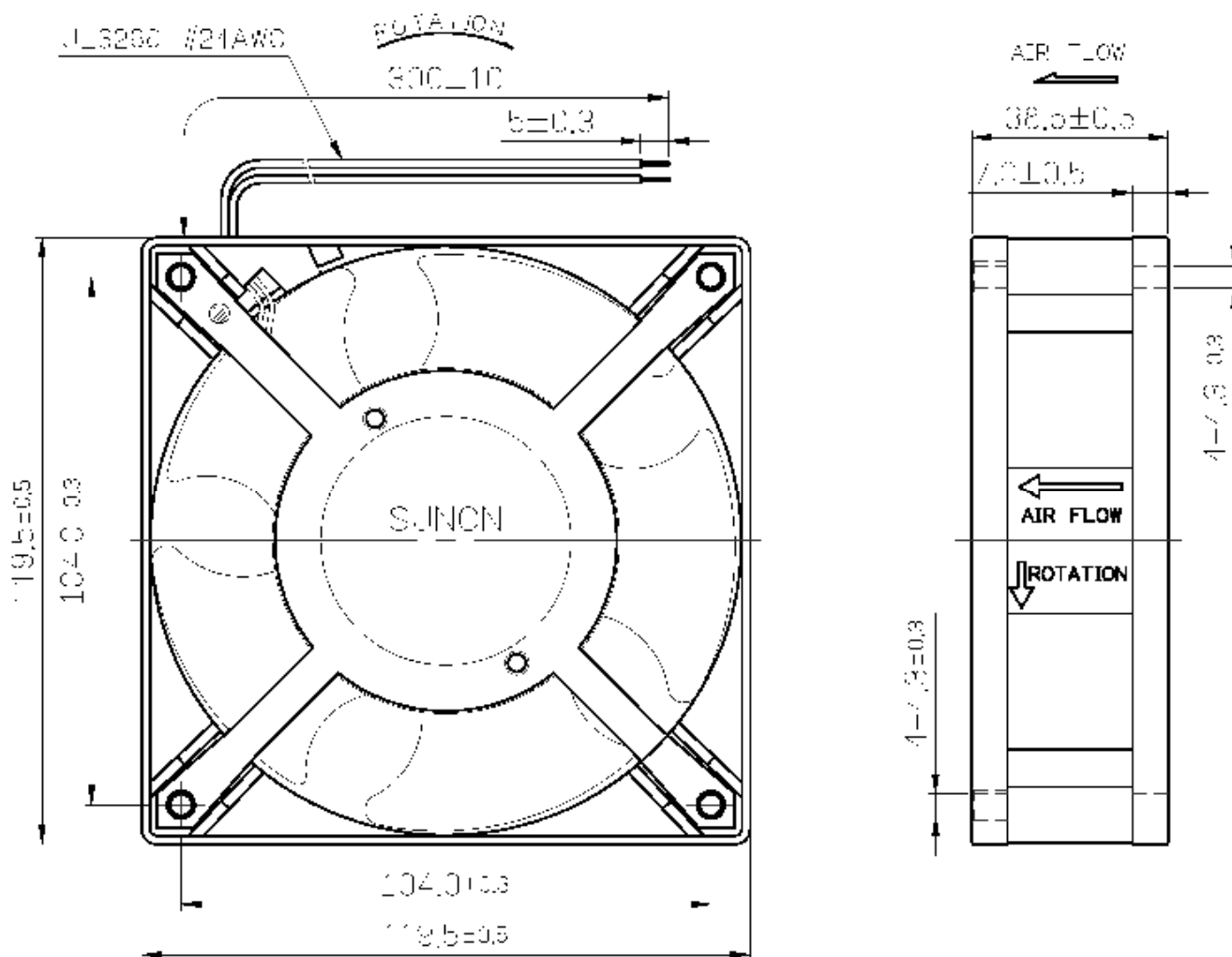
